Director Giammarese informed the Commissioners that the Sgt/Officers that recently completed 6; 12; or 18 months of Probation are doing fine. In addition, Officer Czesak will graduate the Academy on April 13<sup>th</sup> and Officer Johnson will begin the Academy on April 2, 2018. Officer Curio is currently in the FTO Program due to already completing the Academy through Chicago Police Department.

Director Giammarese explained that Ofc. Giovenco's vehicle crash resulted with an eye injury where the air-bag hit his eye. He is pursuing a Workman's Comp. Claim.

Director Giammarese stated that Officer Bzdelik who was deployed shortly after completion of the Academy has returned and is working through his FTO Program.

Officer Lewis Retired after 30 years on February 22, 2018. He hopes to return as a CSO if a position becomes available.

Officers Czesak and Curio will be Sworn In on Monday, March 26, 2018.

Director Giammarese informed the Commissioners that he is seeking approval from the Village Board to for an additional Sergeant. This created position would handle Special Events; Training; Administrative ect.... He has received a "passive" approval from the Board and will soon be seeking formal approval.
