COVERAGE/FLOOR AREA RATIO – (SECOND HEARING) – ZBA 2014-002

The Affidavit of Compliance and the green cards were all submitted to Ms. Herson.

Moved by Commissioner Zevan, seconded by Commissioner Linderman to recommend (1) a variation to allow a rear building setback of 26 feet, 1 inch instead of a minimum required rear building setback of 40 feet; (2) a variation to allow a floor area ratio of .43 instead of the maximum allowed floor area ratio of .35; (3) a variation to allow a lot coverage of 35.2 percent instead of the maximum permitted coverage of 25 percent; and(4) a variation to allow coverage in the rear yard for the site plan, dated April 14, 2014 subject to approval by the Homeowner's Association for the Subdivision.


