Bloomingdale Village Board of Trustees**

**VILLAGE BOARD MEETING
MONDAY – December 14, 2020**

A RESOLUTION AUTHORIZING AND APPROVING A FINANCIAL REIMBURSEMENT INTERGOVERNMENTAL AGREEMENT BETWEEN BLOOMINGDALE TOWNSHIP AND THE VILLAGE OF BLOOMINGDALE FOR PARATRANSIT SERVICES was approved.

A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF THE SOLID WASTE COLLECTION AND DISPOSAL CONTRACT BETWEEN THE VILLAGE OF BLOOMINGDALE AND SBC WASTE SOLUTIONS was approved.

AN ORDINANCE ADOPTING REGULATIONS TO ESTABLISH A LICENSING PROGRAM FOR RESIDENTIAL DWELLING RENTALS WITHIN THE VILLAGE OF BLOOMINGDALE; AMENDING VILLAGE CODE TITLE 4 (BUSINESS AND LICENSE REGULATIONS); ADOPTING CHAPTER 11 RESIDENTIAL DWELLING RENTAL REGULATIONS was approved.

A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF THE PARKING LOT USE LICENSE AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE AND OLD TOWN PROPERTY OWNERS ASSOCIATION; (OLD TOWN) was approved.

AN ORDINANCE AMENDING ORDINANCE 2018-13 AND APPROVAL OF FINAL SITE PLAN APPROVAL FOR THE PROPERTY AT THE SOUTHWEST CORNER OF SPRINGFIELD DRIVE AND SCHICK ROAD; (BLOOMINGDALE WALK) was approved.

AN ORDINANCE DISCONNECTING PROPERTY FROM THE VILLAGE OF BLOOMINGDALE AND APPROVING AND AUTHORIZING THE EXECUTION OF A DISCONNECTION AGREEMENT was approved.

AN ORDINANCE LEVYING TAXES FOR CORPORATE PURPOSES OF THE VILLAGE OF BLOOMINGDALE FOR THE CURRENT FISCAL YEAR COMMENCING ON MAY 1, 2020 TO APRIL 30, 2021
