**A Summary of Recent Actions Taken by the
Bloomingdale Village Board of Trustees**

**VILLAGE BOARD MEETING
MONDAY – MARCH 22, 2010**

AN ORDINANCE ABATING LEVY OF TAX AUTHORIZED BY ORDINANCE 2007-34, AN ORDINANCE AUTHORIZING THE ISSUANCE OF \$4,900,000.00 GENERAL OBLIGATION BONDS, SERIES 2007A, OF THE VILLAGE OF BLOOMINGDALE, ILLINOIS was approved.

AN ORDINANCE ABATING LEVY OF TAX AUTHORIZED BY ORDINANCE 2007-35, AN ORDINANCE AUTHORIZING THE ISSUANCE OF \$4,800,000.00 GENERAL OBLIGATION BONDS, SERIES 2007B, OF THE VILLAGE OF BLOOMINGDALE, ILLINOIS was approved.

AN ORDINANCE ABATING LEVY OF TAX FOR THE PAYMENT OF BONDS ISSUED TO REFUND THE 2001 BONDS THAT REFUNDED OBLIGATION FOR OPEN SPACE PURPOSES AUTHORIZED BY ORDINANCE 2009-34, AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$11,265,000 GENERAL OBLIGATION REFUNDING BONDS, SERIES 2009, OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, AND PROVIDING FOR THE LEVY AND COLLECTION OF A DIRECT ANNUAL TAX SUFFICIENT FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON SAID BONDS was approved.

AN ORDINANCE ABATING LEVY OF TAX FOR THE PAYMENT OF BONDS ISSUED TO REFUND THE 2002 BONDS THAT REFUNDED OBLIGATIONS OF THE VILLAGE ISSUED FOR WATER AND SEWER PURPOSES AUTHORIZED BY ORDINANCE 2009-34, AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$11,265,000 GENERAL OBLIGATION REFUNDING BONDS, SERIES 2009, OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, AND PROVIDING FOR THE LEVY AND COLLECTION OF A DIRECT ANNUAL TAX SUFFICIENT FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON SAID BONDS was approved.

AN ORDINANCE ABATING LEVY OF TAX AUTHORIZED BY ORDINANCE 2009-52, AN ORDINANCE LEVYING TAXES FOR CORPORATE PURPOSES OF THE VILLAGE OF BLOOMINGDALE FOR THE CURRENT FISCAL YEAR COMMENCING ON MAY 1, 2009 TO APRIL 30, 2010 was approved.

AN ORDINANCE AMENDING ORDINANCE 2010-08, REGARDING A SIMPLIFIED MUNICIPAL TELECOMMUNICATIONS TAX FOR THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS was approved.

CHANGE ORDERS

2009 LOCAL DRAINAGE PROJECT with Patnick Construction, Inc., Change Order No. 1 in the total additional amount of \$6,306.07 was approved. The total current contract amount is \$179,614.07.

CONTRACTS, BIDS, & PURCHASES

CONVERSION OF THE FINANCE DEPARTMENT UNIX SERVER to a Linus server and implementation of the Barracuda data backup service was approved at a cost not-to-exceed \$30,000.00.

THE 2010 MULTI-YEAR TREE PRUNING MAINTENANCE PROGRAM rejection of bid proposals received on March 2, 2010 was approved. The program was approved to be re-bid.

REPUBLIC SERVICES (formerly Allied Waste) contract for residential refuse, recycling and yard waste change of collection days from Wednesday-Thursday-Friday to Thursday-Friday was approved. These changes in collection days are to be effective starting April 8, 2010.

FINANCE & PERSONNEL

A RESOLUTION PROVIDING FOR ANNUAL REVIEW OF NEED FOR SIMPLIFIED TELECOMMUNICATIONS TAX was adopted.

WARRANT #2 FOR THE MONTH OF MARCH, 2010 in the amount of \$1,072,448.30 was approved as presented.

PLANNING, ZONING & ENVIRONMENTAL CONCERNS

A PROPOSAL CONCERNING THE REVOCATION OF PET RESCUE'S special use permit heretofore granted under Ordinance 79-23 for the use of the property at 151 N. Bloomingdale Road as and for an animal sanctuary and pet hostelry for dogs and cats and the repeal of Ordinance 79-23 was presented. The Board authorized the preparation of an ordinance.
