**A Summary of Recent Actions Taken by the
Bloomingdale Village Board of Trustees**

**VILLAGE BOARD MEETING
MONDAY – APRIL 25, 2011**

AN ORDINANCE AUTHORIZING THE SALE OR DISPOSAL OF SURPLUS PROPERTY OWNED BY THE VILLAGE OF BLOOMINGDALE was passed.

AN ORDINANCE AMENDING ORDINANCE NO. 2009-45 AND GRANTING FINAL SITE PLAN APPROVAL TO ALLOW THE EXPANSION OF AN EXISTING OUTDOOR PATIO (152 STRATFORD SQUARE - BALLYDOYLE IRISH PUB AND RESTAURANT) was passed.

WARRANT #2 FOR THE MONTH OF APRIL, 2011 in the amount of \$1,622,664.17 was approved as presented.

BINNY'S BEVERAGE DEPOT presented their proposal for approval of an amendment to Ordinance No. 92-39; a special use permit to allow a package liquor store; a special use permit to allow a planned development; an exception to the sign ordinance for wall signage; exceptions from the zoning ordinance; and final site plan at 353 West Army Trail Road. The Board authorized the preparation of an ordinance.

EDWARDS ENGINEERING, INC. of Elk Grove Village, IL was awarded a one-year extension to their Heating, Ventilation and Air Conditioning Maintenance Contract in the amount of \$36,794.00. This is year four of a five-year contract.

MEADE ELECTRIC COMPANY, INC. of McCook, IL was awarded a one-year extension to their contract for Street Light Maintenance in the amounts of \$55,000.00 for base maintenance and \$26,000.00 for utility location services. This is final year of a six-year contract.

MEADE ELECTRIC COMPANY, INC. of McCook, IL was awarded a one-year extension to their contract for Traffic Signal Maintenance in the amounts of \$8,560.00 for maintenance and \$1,500.00 for specialty work. This is the final year of a six-year contract.

TESTING SERVICE CORPORATION of 360 South Main Place, Carol Stream, IL was awarded the contract for QC/QA Professional Material Testing and Reporting Services concerning the 2011 Road Rehabilitation Program in the amount of \$13,458.00.

TLC GROUP, LTD. of 160 East Burlington Avenue, Clarendon Hills, IL was awarded a five (5) year contract for Landscape Maintenance Services at Village Facilities and Rights-Of-Way in the amount of \$32,073.75 for base maintenance plus a prescribed schedule for emergency and specialty work.
