**VILLAGE BOARD MEETING**

**MONDAY – AUGUST 27, 2012**

**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 6 (POLICE & PUBLIC SAFETY); CHAPTER 5 (GENERAL OFFENSES); SECTION 8 (RETAIL THEFT); SUBSECTION F. (VALUE OF GOODS) was adopted.**

**AN ORDINANCE APPROVING AN AMENDMENT TO ORDINANCE NO. 2007-38 (AN ORDINANCE GRANTING A REZONING, SPECIAL USE PERMIT TO ALLOW A PLANNED DEVELOPMENT WITH EXCEPTIONS TO THE ZONING ORDINANCE, A SPECIAL USE PERMIT TO ALLOW A CHURCH, A SPECIAL USE PERMIT TO ALLOW COLLECTIVE OFF-STREET SHARED PARKING WITH EXCEPTIONS REGARDING OWNERSHIP AND ZONING OF SAID PARKING FACILITY, AND FINAL SITE PLAN APPROVAL); APPROVAL OF A SPECIAL USE PERMIT TO ALLOW A DAY CARE CENTER, EXCEPTIONS TO THE ZONING CODE AND SUBDIVISION REGULATIONS; AND A FINAL SITE PLAN (GOOD SHEPHERD DAY CARE, 286 GLEN ELLYN ROAD) was adopted.**

**A RESOLUTION APPROVING A COLLECTIVE BARGAINING AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE AND THE INTERNATIONAL UNION OF OPERATING ENGINEERS, LOCAL 150, PUBLIC EMPLOYEES DIVISION was adopted.**

**WARRANT #2 FOR THE MONTH OF AUGUST, 2012 in the amount of \$757,952.88 was approved as presented.**

**TREASURER'S REPORT FOR THE 1<sup>ST</sup> QUARTER OF FISCAL YEAR 13 was approved.**

**THE CONTRACTUAL PROGRAM BETWEEN CHOOSE DUPAGE AND BUXTON COMPANY for the provision of an economic development information program in an amount not to exceed \$4,500.00 was approved.**

**A CONSOLIDATED DISPATCH UPDATE was provided to the Village Board.**
