**A Summary of Recent Actions Taken by the
Bloomingdale Village Board of Trustees**

VILLAGE BOARD MEETING

MONDAY – DECEMBER 10, 2012

AN ORDINANCE LEVYING TAXES FOR CORPORATE PURPOSES OF THE VILLAGE OF BLOOMINGDALE FOR THE CURRENT FISCAL YEAR COMMENCING ON MAY 1, 2012 TO APRIL 30, 2013 was approved. A Truth in Taxation public hearing concerning the 2012 proposed tax levy was held prior to the adoption of the ordinance.

AN ORDINANCE AUTHORIZING THE SALE OF SURPLUS PERSONAL PROPERTY OWNED BY THE VILLAGE OF BLOOMINGDALE BY AN ON-LINE AUCTION was approved.

AN ORDINANCE APPROVING SPECIAL USE PERMITS FOR TABLESIDE ALCOHOLIC BEVERAGE SERVICE AND OUTDOOR DINING, FINAL SITE PLAN APPROVAL AND REPEALING ORDINANCE NO. 91 - 41 (AN ORDINANCE GRANTING FINAL SITE PLAN APPROVAL FOR THE CONSTRUCTION AND OPERATION OF AN OUTDOOR PLAYGROUND AS AN ACCESSORY USE TO THE BURGER KING RESTAURANT LOCATED AT 84 STRATFORD DRIVE IN THE STRATFORD PLANNED UNIT DEVELOPMENT) IN ITS ENTIRETY WITHOUT REPLACEMENT (EL BURRITO LOCO, 84 STRATFORD DRIVE) was approved.

A RESOLUTION AUTHORIZING AND APPROVING A FINANCIAL REIMBURSEMENT INTERGOVERNMENTAL AGREEMENT BETWEEN BLOOMINGDALE TOWNSHIP AND THE VILLAGE OF BLOOMINGDALE FOR PARATRANSIT SERVICES was adopted.

A RESOLUTION AUTHORIZING AND APPROVING THE EXECUTION OF A FINANCIAL REIMBURSEMENT INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE AND BLOOMINGDALE TOWNSHIP (MOSQUITO ABATEMENT SERVICES) was adopted.

THE AMENDED FILING DATES OF PETITIONS FOR THE APRIL 9, 2013 CONSOLIDATED ELECTION were announced. Petitions circulated for Independent, New Party and Non-Municipal Nonpartisan office candidates will be accepted beginning on December 17 through December 26, 2012 from 8:30 a.m. to 4:30 p.m. except the last day of filing when the office will remain open until 5:00 p.m. The State legislature extended the last day of filing to December 26, 2012. The Village Hall offices will be closed on Monday, December 24 and Tuesday, December 25, 2012.
