**A Summary of Recent Actions Taken by the
Bloomingdale Village Board of Trustees**

VILLAGE BOARD MEETING

MONDAY – FEBRUARY 27, 2012

MAYOR IDEN SWORE IN JEREMY REDIC AS A PROBATIONARY POLICE OFFICER. Officer Redic is presently attending the Suburban Law Enforcement Academy.

A TOWN HALL INFORMATIONAL MEETING has been scheduled for **Wednesday, March 14, 2012 at 7:00 p.m. at the Bloomingdale Golf Club, 181 Glen Ellyn Road, Bloomingdale** to discuss questions and concerns regarding the decommissioning of the Village of Bloomingdale's Police Public Safety Answering Point (PSAP), consolidation of Police 9-1-1 services with the Addison Central Dispatch Center and participation and progress in the DuPage Emergency Dispatch Interoperable Radio system.

AN ORDINANCE APPROVING THE OFFICIAL ZONING MAP OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS was approved.

AN ORDINANCE AMENDING CHAPTER 13 OF THE BLOOMINGDALE COMPREHENSIVE CODE TO PROVIDE FOR LIQUOR CONTROL, SECTION 13-1-10 (NUMBER OF LICENSES) TO DECREASE THE NUMBER OF CLASS "D" LICENSES (RT CHICAGO FRANCHISE, LLC – D/B/A RUBY TUESDAY) was approved.

A RESOLUTION TO ALLOW THE VILLAGE OF BLOOMINGDALE TO UNDERTAKE CONSTRUCTION, OPERATION AND MAINTENANCE OF DRIVEWAYS AND STREET RETURNS, WATERMAIN, SANITARY AND STORM SEWERS, STREET LIGHTS, TRAFFIC SIGNALS, SIDEWALKS, AND LANDSCAPING, ETC., ON STATE HIGHWAYS WITHIN THE VILLAGE OF BLOOMINGDALE was adopted.

A RESOLUTION TO ADOPT MUNICIPAL LEGISLATIVE POSITIONS AND PRIORITIES FOR THE 2012 LEGISLATIVE SESSION AS RECOMMENDED BY THE DUPAGE MAYORS & MANAGERS CONFERENCE IN THEIR LETTER DATED FEBRUARY 7, 2012 was adopted.

THE TREASURER'S REPORT FOR THE THIRD QUARTER OF FISCAL YEAR 2012 was approved as presented.

WARRANT #2 FOR THE MONTH OF FEBRUARY, 2012 in the amount of \$961,418.69 was approved as presented.
