A Summary of Recent Actions Taken by the Bloomingdale Village Board of Trustees

VILLAGE BOARD MEETING

MONDAY – JULY 23, 2012

AN ORDINANCE AMENDING THE VILLAGE CODE OF BLOOMINGDALE, AS AMENDED, TITLE 10 (BUILDING AND DEVELOPMENT); CHAPTER 1 (BUILDING PERMITS, FEES AND BONDS); SECTION 1-2 (BONDS); SECTION 1-3 (ENGINEERING PROVISIONS); SECTION 2-2 (ENGINEERING DIVISION PLAN REVIEW AND INSPECTION PERMIT SCHEDULE OF FEES); AND CHAPTER 12 (STORMWATER MANAGEMENT AND FLOOD CONTROL); SECTION 1 (COUNTY REGULATIONS ADOPTED); REPEALING SECTION 2 (APPLICATION TO ANNEXATION) IN ITS ENTIRETY; ADDING A NEW SECTION 2 (COMPLETE WAIVER COMMUNITY STAFFING) AND ADDING A NEW SECTION 3 (COMPLETE WAIVER COMMUNITY COMMITMENTS); IN ORDER TO ADOPT THE APPLICABLE PROVISIONS, APPENDICES, EXHIBITS AND SCHEDULES OF THE COMPREHENSIVE AMENDMENT TO THE COUNTY OF DUPAGE COUNTYWIDE STORMWATER AND FLOODPLAIN ORDINANCE DATED APRIL 25, 2012; AND ADOPTING GENERAL CERTIFICATIONS PURSUANT TO PROVISIONS OF THE DUPAGE COUNTY COUNTYWIDE STORMWATER AND FLOOD PLAIN ORDINANCE; AND PETITIONING DUPAGE COUNTY FOR A COMPLETE WAIVER OF ENFORCEMENT OF THE PROVISIONS OF SAID ORDINANCE BY THE COUNTY OF DUPAGE WITHIN THE CORPORATE LIMITS OF THE VILLAGE OF BLOOMINGDALE; AND ADOPTING REVISED VILLAGE FEE SCHEDULES TO TAKE EFFECT ON JULY 25, 2012 was adopted.

AN ORDINANCE APPROVING AN AMENDMENT TO A FINAL SITE PLAN TO ALLOW A MODIFICATION TO THE BUILDING ELEVATIONS APPROVED PURSUANT TO ORDINANCE NO. 90-64 (AN ORDINANCE GRANTING FINAL SITE PLAN APPROVAL AND A SPECIAL USE PERMIT FOR THE COMMERCIALLY ZONED PORTION OF THE COVINGTON CORPORATE CENTER PUD FOR THE CONSTRUCTION AND OPERATION OF A DOMINICKS, K-MART AND OTHER SMALL RETAIL SHOPS (STRATFORD PROMENADE)); AND THE REPEAL OF ORDINANCE NO. 93-01 (AN ORDINANCE GRANTING SIGNAGE APPROVAL FOR WALL SIGNS FOR A 33,008 SQUARE FOOT RETAIL BUILDING AT STRATFORD PLAZA SHOPPING CENTER SOUTHWEST QUADRANT, GARY AVENUE AND SCHICK ROAD (CIRCUIT CITY)) IN ITS ENTIRETY (STRATFORD CROSSING SHOPPING CENTER, 152 SOUTH GARY AVENUE) was adopted.

AN ORDINANCE APPROVING A PLAT OF RESUBDIVISION FOR BLOOMINGDALE COURT/WAL-MART RESUBDIVISION OF LOTS 11 AND 15, LOCATED AT 314 WEST ARMY TRAIL ROAD IN THE VILLAGE OF BLOOMINGDALE, ILLINOIS was adopted.

AN ORDINANCE VACATING CERTAIN PUBLIC UTILITY AND INGRESS AND EGRESS EASEMENTS IN THE BLOOMINGDALE COURT/WAL-MART RESUBDIVISION OF LOTS 11 AND 15 IN THE VILLAGE OF BLOOMINGDALE, ILLINOIS was adopted.

AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 3 (FINANCE & TAXATION), CHAPTER 2 (PURCHASING AND PROCUREMENT PROCEDURES); SECTION 2 (PURPOSE AND INTERPRETATION); SECTION 7 (COMPETITIVE BIDDING AND ADVERTISING PROCEDURES AND REQUIREMENTS); AND SECTION 11 (PREVAILING WAGE FOR PUBLIC WORKS CONTRACTS) was adopted.
