**A Summary of Recent Actions Taken by the
Bloomingdale Village Board of Trustees**

VILLAGE BOARD MEETING

MONDAY – JUNE 11, 2012

MAYOR IDEN REAPPOINTED FRANK LETIZIA TO THE BOARD OF FIRE AND POLICE COMMISSIONERS; GUY SANALITRO AND ALEX ZEVA III TO THE PLAN COMMISSION AND ZONING BOARD OF APPEALS; ALAN BIRKLEY TO THE POLICE PENSION BOARD AND VIVI FRUMKIN AND MITCH FRUMKIN TO THE SEPTEMBERFEST COMMISSION.

WARRANT #1 FOR THE MONTH OF JUNE, 2012 in the amount of \$1,463,482.78 was approved as presented.

AN ORDINANCE APPROVING AN AMENDMENT TO ORDINANCE NO. 94-11 (AN ORDINANCE GRANTING SITE PLAN APPROVAL FOR CONSTRUCTION AND OPERATION OF A 6,279 SQUARE-FOOT SIT-DOWN RESTAURANT ON AN OUTLOT IN THE STRATFORD PLAZA PLANNED UNIT DEVELOPMENT AND GRANTING A SPECIAL USE PERMIT FOR SALE AND SERVICE OF ALCOHOLIC BEVERAGES ON THE PREMISES IN CONJUNCTION WITH FOOD SERVICE AND GRANTING A SPECIAL USE PERMIT FOR SHARED PARKING); A SPECIAL USE PERMIT; AN EXCEPTION FROM THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 11 (ZONING REGULATIONS), CHAPTER 14 (SIGNS); SECTION 11 (SIGNS IN BUSINESS DISTRICTS); AND A FINAL SITE PLAN; AND REPEALING ORDINANCE NO. 2001-15 AND ORDINANCE NO. 95-55 IN THEIR ENTIRETY WITHOUT REPLACEMENT (BUFFALO WILD WINGS, 140 SOUTH GARY AVENUE) was adopted.

AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES) TO INCREASE THE NUMBER OF CLASS "D" LICENSES (Blazin Wings, Inc., D/B/A Buffalo Wild Wings Grill & Bar) was adopted.

APPOINTED VILLAGE CLERK REFERENDUM QUESTION was discussed.

INDIAN LAKES OPEN SPACE DRAFT REQUEST FOR PLANNING/LANDSCAPING/MAINTENANCE PROPOSAL was discussed.

AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 11 (ZONING REGULATIONS), CHAPTER 4 (SITE DEVELOPMENT AND PLAN REVIEW), SECTION 4 (STANDARDS OF DEVELOPMENT); CHAPTER 5 (GENERAL ZONING PROVISIONS), SECTION 11 (PERMITTED OBSTRUCTIONS - YARDS); CHAPTER 8 (BUSINESS DISTRICTS), ARTICLE C (B-2 COMMUNITY BUSINESS DISTRICT), SECTION (SPECIAL USES); CHAPTER (10 (PLANNED DEVELOPMENT DISTRICTS), ARTICLE B (PLANNED UNIT DEVELOPMENT 250 ACRES OR MORE), SECTION 7 (LOCATION OF BUILDINGS); CHAPTER 11 (OTP OLD TOWN PRESERVATION DISTRICT), ADDING A NEW SECTION 8 (FENCING); CHAPTER 13 (OFF STREET PARKING AND LOADING), SECTION 2 (SCOPE) AND SECTION 4 (OFF STREET PARKING REGULATIONS); CHAPTER 14 (SIGNS), SECTION 3 (DEFINITIONS), SECTION 6 (SIGNS NOT REQUIRING A PERMIT), SECTION 8 (GENERAL SIGN REGULATIONS), SECTION 9 (SIGNS IN ALL DISTRICTS), SECTION 11 (SIGNS IN BUSINESS DISTRICTS (B-1, B-2, B-3, B-4) AND FOR COMMERCIAL USES IN PLANNED UNIT DEVELOPMENT DISTRICTS OF 250 ACRES OR MORE), AND SECTION 12 (SIGNS IN O-D OFFICE DISTRICTS) ESTABLISHING NEW OR AMENDED REGULATIONS PERTAINING TO SITE PLAN REVIEW REQUIREMENTS, FENCING, SIGNAGE, SPECIAL USES, AND OFF STREET PARKING AND LOADING WITHIN THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS was adopted.
