**A Summary of Recent Actions Taken by the
Bloomingdale Village Board of Trustees**

VILLAGE BOARD MEETING

MONDAY – MARCH 12, 2012

AN ORDINANCE ADOPTING THE VILLAGE OF BLOOMINGDALE MUNICIPAL CODE, EXCLUDING TITLE 11 (ZONING REGULATIONS), AS AN EXERCISE OF THE HOME RULE AUTHORITY OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS was approved.

A RESOLUTION APPROVING A MASTER ELECTRICITY SALES AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS AND EXELON ENERGY COMPANY was adopted.

A RESOLUTION FOR IMPROVEMENT BY MUNICIPALITY UNDER THE ILLINOIS HIGHWAY CODE (2012 STREET IMPROVEMENT PROGRAM IN FY 13) was adopted.

A REMINDER ON THE TOWN HALL INFORMATIONAL MEETING was given. The meeting has been scheduled for **Wednesday, March 14, 2012 at 7:00 p.m. at the Bloomingdale Golf Club, 181 Glen Ellyn Road, Bloomingdale** to discuss questions and concerns regarding the decommissioning of the Village of Bloomingdale's Police Public Safety Answering Point (PSAP), consolidation of Police 9-1-1 services with the Addison Central Dispatch Center and participation and progress in the DuPage Emergency Dispatch Interoperable Radio system.

WARRANT #1 FOR THE MONTH OF MARCH, 2012 in the amount of \$1,178,149.46 was approved as presented.

TOWN MANAGEMENT, LLC (Wilshire Towers Apartments) presented their proposal for approval of a final site plan and other related zoning relief to allow the construction of a club house at 201 Regency Drive. The Board authorized the preparation of an ordinance.

CONTRACTS, BIDS, & PURCHASES

A LAMP CONCRETE of 1900 Wright Boulevard, Schaumburg, Illinois was awarded the contract for the 2012 Street Improvement Program in the amount of \$713,670.40.

CURRIE MOTORS FLEET of 9423 West Lincoln Highway, Frankfort, Illinois, was awarded the contract for the purchase of three (3) Ford Police Interceptor vehicles through the Suburban Purchasing Cooperative, in the amount of \$80,187.00.

MAINTENANCE COATINGS COMPANY of 543 Woodbury Street, South Elgin, Illinois was awarded the bid for the 2012 Pavement Marking Program in the amount of \$48,921.85.

MARKING SPECIALISTS CORPORATION of P.O. Box 745, Arlington Heights, Illinois was awarded the bid for the 2012 Pavement Inlay Marking Program in the amount of \$6,578.15

MORROW BROTHERS FORD INC. of Rural Route 2, Box 120, Greenfield, Illinois, was awarded the contract for the purchase of a Ford F-150 Crew Cab Pick-Up through the State of Illinois Joint Purchase Contract #4016059, in the amount of \$27,819.00.
