**A Summary of Recent Actions Taken by the  
Bloomingdale Village Board of Trustees**

**VILLAGE BOARD MEETING**

**MONDAY – MAY 14, 2012**

**MAYOR IDEN SWORE IN SAM BONILLA AS A SERGEANT OF POLICE.** He was promoted to the rank of Sergeant effective May 12, 2012.

**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES) TO DECREASE THE NUMBER OF CLASS "P" LICENSES (DOMINICK'S FINER FOODS, LLC, STORE #3139) was adopted.**

**AN ORDINANCE AUTHORIZING AND APPROVING THE EXECUTION OF AN INTERGOVERNMENTAL TRANSFER AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS AND THE BOARD OF EDUCATION OF COMMUNITY CONSOLIDATED SCHOOL DISTRICT #93, DUPAGE COUNTY, ILLINOIS AND REPEALING ORDINANCE NO. 2012-21 (AN ORDINANCE AUTHORIZING AND APPROVING THE EXECUTION OF AN INTERGOVERNMENTAL TRANSFER AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS AND THE BOARD OF EDUCATION OF COMMUNITY CONSOLIDATED SCHOOL DISTRICT #93, DUPAGE COUNTY, ILLINOIS) was adopted.**

**A RESOLUTION APPROVING THE OPERATING AND CAPITAL BUDGET FOR THE VILLAGE OF BLOOMINGDALE FOR THE FISCAL YEAR COMMENCING ON MAY 1, 2012 AND ENDING ON APRIL 30, 2013 was adopted.**

**WARRANT #1 FOR THE MONTH OF MAY, 2012** in the amount of \$1,292,256.24 was approved as presented.

**FACILITIES, INFRASTRUCTURE**

**EDWARDS ENGINEERING**, 1000 Touhy Avenue, Elk Grove Village, Illinois was awarded the contract for the Police Department Boiler Repair in the amount of \$22,350.00.

**LAYNE CHRISTENSEN WATER RESOURCES**, 721 West Illinois Avenue, Aurora, Illinois was awarded the contract for the Abandonment of Well #8 in the amount of \$44,575.00.

**FINANCE AND ADMINISTRATION**

**THE BOARD ACCEPTED** the Five (5) Year Forecast for the Governmental Funds dated April, 2012; the Five (5) Year Forecast for the Water & Sewer Funds dated April, 2012; and the Five (5) Year Forecast for the Golf Operations Fund dated December, 2011.

**PLANNING, ZONING & ENVIRONMENTAL CONCERNS**

**THE BOARD RATIFIED THE ACTIONS OF VILLAGE STAFF IN RELEASING OAK BROOK BANK LETTER OF CREDIT NO. 4931** to MB Financial Bank, N.A., the successor bank to Oak Brook Bank, in exchange for a payment of a one time lump sum contribution of \$6,000.00 toward the future construction of a sidewalk as a minor change to Section 4, Paragraph B of Ordinance No. 2004-32 (Len's Ace Hardware, 272 Lake Street).

**A PROPOSAL TO APPROVE CERTAIN TEXT AMENDMENTS TO TITLE 11 (ZONING REGULATIONS)**, Concerning Signage, Special Uses, Fencing, Off-Street Parking and Requirements for Site Plan Review as discussed at the Combined Village Board and Committee of the Whole Meeting on May 14, 2012 was presented. The Board authorized the preparation of an ordinance.
