**VILLAGE BOARD MEETING**

**MONDAY – OCTOBER 22, 2012**

**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 1 (ADMINISTRATION); CHAPTER 7 (VILLAGE CLERK); SECTION 1 (ELECTED OFFICIAL) AND SECTION 2 (DUTIES); TO ESTABLISH THE DUTIES AND RESPONSIBILITIES OF THE VILLAGE CLERK** was held in Committee.

**A RESOLUTION APPROVING ADMINISTRATIVE POLICY NO. 6.2 – (RECOGNITION AND ACKNOWLEDGEMENT) OF EMPLOYEES, ELECTED OFFICIALS, COMMISSION MEMBERS, VOLUNTEER WORKERS AND VOLUNTEER ORGANIZATIONS OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS** was adopted.

**A RESOLUTION APPROVING ADMINISTRATIVE POLICY NO. 6.3 – (EVENTS AND OUTINGS) FOR EMPLOYEES AND ELECTED OFFICIALS OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS** was adopted.

**A RESOLUTION AUTHORIZING AND APPROVING A 3<sup>RD</sup> AMENDMENT TO THE NON-EXCLUSIVE LICENSE AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE AND SPRINTCOM, INC., TO PERMIT A UTILITY ACCESS AREA TO INSTALL FIBER OPTIC CABLES/LINES ACROSS, UNDER OR UPON VILLAGE PROPERTY (CARDINAL WATER TOWER)** was adopted.

**A RESOLUTION AUTHORIZING AND APPROVING A 2<sup>ND</sup> AMENDMENT TO THE NON-EXCLUSIVE LICENSE AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE AND SPRINTCOM, INC., TO PERMIT A UTILITY ACCESS AREA TO INSTALL FIBER OPTIC CABLES/LINES ACROSS, UNDER OR UPON VILLAGE PROPERTY (WINSTON WATER TOWER)** was adopted.
