A Summary of Recent Actions Taken by the Bloomingdale Village Board of Trustees

**VILLAGE BOARD MEETING
MONDAY – AUGUST 12, 2013**

AN ORDINANCE REPEALING ORDINANCE NO. 86-19 (AN ORDINANCE REZONING LAND AMERICA COMPANY PROPERTY SOUTH OF SCHICK ROAD FROM B-1 SINGLE FAMILY RESIDENTIAL TO B-3 PLANNED UNIT DEVELOPMENT) AND ORDINANCE NO. 2005 - 46 (AN ORDINANCE APPROVING A FINAL SITE PLAN, SPECIAL USE PERMITS, PRELIMINARY SITE PLAN APPROVAL FOR A NON-MEDICAL OFFICE BUILDING AND EXCEPTIONS TO THE ZONING ORDINANCE FOR JAMESON'S CHARHOUSE DEVELOPMENT, SOUTH SIDE OF SCHICK ROAD, WEST OF MAGAZINE ENTRANCE NO. 1 OF THE STRATFORD SQUARE MALL) IN THEIR ENTIRETY AND APPROVING A FINAL PLAT OF SUBDIVISION, A SPECIAL USE PERMIT FOR SHARED PARKING, EXCEPTIONS FOR SHARED PARKING AND EXISTING PAVEMENT AND BUILDING SETBACKS, FOR ANGELOS' SCHICK ROAD SUBDIVISION (94 STRATFORD DRIVE) was approved.

A RESOLUTION AUTHORIZING APPROVING A LEGAL SERVICES AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS AND CERTAIN LEGAL FIRMS CONCERNING A CLASS ACTION SUIT PURSUING THE COLLECTION OF UNREMITTED HOTEL/MOTEL TAXES was adopted.

A TEMPORARY LAND USE PERMIT FOR THE HILTON INDIAN LAKES RESORT, 250 West Schick Road, to allow outdoor dining and entertainment on the Masters Patio for Wednesday, July 9th, Friday, July 11th, Sunday, July 13th, Tuesday, July 15th, and Thursday, July 17th in 2014 was approved.

A TEMPORARY LAND USE PERMIT FOR FOUR SEASONS OF FUN, 140 East Lake Street, in the Springbrook Shopping Center, to allow a tent sale to continue until September 8, 2013 which exceeds the amount of time allowed in the Village's Zoning Regulations was approved.

WARRANT #1 FOR THE MONTH OF AUGUST, 2013 in the amount of \$1,819,796.37 was approved as presented.

VARIOUS (3) YEAR BUSINESS CLASS TELECOMMUNICATION SERVICES ORDER AGREEMENTS for Village Facilities at a rate of \$4,325.15 per month with Comcast Business Services/Cimco Communications were approved.

PINE LANDSCAPING of 27W021 St. Charles Road, Carol Stream, Illinois, was approved as the vendor for the Landscape Maintenance Contract in the amount of \$26,533.34 for the remainder of FY 14.
