**VILLAGE BOARD MEETING**

**MONDAY – JANUARY 14, 2013**

**MAYOR IDEN SWORE IN DOMINICK J. CORSIGLIA AS A PROBATIONARY POLICE OFFICER.** Officer Corsiglia is presently attending the Suburban Law Enforcement Academy.

**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES); TO DECREASE THE NUMBER OF CLASS "D" LICENSES RESULTING FROM THREE (3) FAILURES TO RENEW LICENSES FOR 2013** was approved.
