**A Summary of Recent Actions Taken by the  
Bloomingdale Village Board of Trustees**

**VILLAGE BOARD MEETING  
MONDAY – JUNE 24, 2013**

**AN ORDINANCE MAKING APPROPRIATIONS FOR CORPORATE PURPOSES FOR THE FISCAL YEAR MAY 1, 2013 TO APRIL 30, 2014** was approved. Prior to adoption, a public hearing was held in order to receive public input.

**AN ORDINANCE APPROVING SPECIAL USE PERMITS FOR ALCOHOLIC BEVERAGE SERVICE AND LIVE ENTERTAINMENT, AND REPEALING ORDINANCE NO. 92-40 (AN ORDINANCE GRANTING A SPECIAL USE PERMIT FOR OPERATION OF EIGHT (8) ELECTRONIC AND TWO (2) MANUAL GAMES WITHIN AN EXPANDED GAME ROOM ON THE PROPERTY OF ROSATI'S PIZZA, A RESTAURANT SERVING ALCOHOLIC BEVERAGES, LOCATED AT 185 EAST LAKE STREET, BLOOMINGDALE, ILLINOIS WITHIN THE CIRCLE CENTER PLANNED UNIT DEVELOPMENT) IN ITS ENTIRETY WITHOUT REPLACEMENT (CESAR'S SPORTS BAR AND GRILL, 185 EAST LAKE STREET)** was approved.

**A RESOLUTION AUTHORIZING THE RELEASE OF EXECUTIVE SESSION MEETING MINUTES** was adopted.

**A RESOLUTION AUTHORIZING THE DESTRUCTION OF AUDIO RECORDINGS OF CLOSED MEETING SESSIONS** was adopted.

**THE VILLAGE BOARD COMMITTEE/LIAISON ASSIGNMENTS** which were presented and discussed at the June 17, 2013 Standing Committee of the Whole meeting were approved.

**WARRANT #2 FOR THE MONTH OF JUNE, 2013** in the amount of \$1,414,103.60 was approved as presented.

**SUNGARD PENTAMATION PUBLIC SECTOR** purchase order for two (2) years of Software Maintenance and Support for the Village's Financial Systems in the amount of \$61,465.34 was approved for signature by the Village Administrator.
