**A Summary of Recent Actions Taken by the  
Bloomingdale Village Board of Trustees**

**VILLAGE BOARD MEETING  
MONDAY – NOVEMBER 25, 2013**

**A PUBLIC HEARING CONCERNING THE VACATION OF A PORTION OF THE SOUTH PRAIRIE AVENUE RIGHT-OF-WAY** was held. The proposed Plat of Vacation and Easement Reservation was presented along with an explanation for the necessity of the Vacation and Easement. A review of the proposed ordinance was discussed.

**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 9 (WATER AND SEWER), CHAPTER 2 (WATER USE AND SERVICE), RETITLED SECTION 3 (GROUND WATER AS POTABLE WATER PROHIBITED) TO PROHIBIT THE USE OF GROUNDWATER AS A POTABLE WATER SUPPLY BY THE INSTALLATION OR USE OF POTABLE WATER SUPPLY WELLS OR BY ANY OTHER METHOD WITHIN A DESIGNATED AREA OF 102 EAST LAKE STREET (FKA BUCHANAN ENERGY MOBIL SERVICE STATION #05, STORE #517)** was passed.

**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 6 (POLICE AND PUBLIC SAFETY); ADDING A NEW CHAPTER 9 (PUBLIC SAFETY EMPLOYEE BENEFITS ACT)** was passed.

**AN ORDINANCE AMENDING ORDINANCE NO. 2013 – 03 PROVIDING FOR A SPECIAL USE PERMIT AND VARIANCE FOR THE PROPERTY COMMONLY REFERRED TO AS 171 COVINGTON DRIVE, BLOOMINGDALE, ILLINOIS ALLOWING FOR ADDITIONAL HEIGHT, EQUIPMENT AND CABINETRY FOR THE EXISTING MONOPOLE** was passed.

**A RESOLUTION AUTHORIZING SCHOOL BUS ACCESS TO THE COMMUNITY CONSOLIDATED SCHOOL DISTRICT 93'S PRE-SCHOOL SITE LOCATED AT 280 OLD GARY AVENUE, BLOOMINGDALE, ILLINOIS (CCSD #93 PRE-SCHOOL SITE)** was adopted.

**A RESOLUTION AUTHORIZING THE EXTERIOR ILLUMINATION OF TWO (2) CANOPIES AT THE MOBIL STATION LOCATED AT 102 EAST LAKE, STREET BLOOMINGDALE, ILLINOIS OWNED AND OPERATED BY DAVID R. HEIDNER (THE HEIDNER MOBIL STATION)** was adopted.

**A RESOLUTION APPROVING A COLLECTIVE BARGAINING AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE AND THE FRATERNAL ORDER OF POLICE LABOR COUNCIL FOR AND ON BEHALF OF POLICE PATROL OFFICERS OF THE VILLAGE OF BLOOMINGDALE** was adopted.
