A Summary of Recent Actions Taken by the Bloomingdale Village Board of Trustees

**VILLAGE BOARD MEETING
MONDAY – OCTOBER 28, 2013**

AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 11 (ZONING REGULATIONS); CHAPTER 5 (GENERAL ZONING PROVISIONS); SECTION 5 (TEMPORARY USES IN UNIFIED SHOPPING CENTERS); AND ADDING A NEW SECTION 7 (CHANGES TO APPROVED PLANS, USES, AND STRUCTURES); AND RENUMBERED SECTION 9 (ACCESSORY BUILDINGS AND USES); CHAPTER 8 (BUSINESS DISTRICTS); ARTICLE B (B-1 NEIGHBORHOOD BUSINESS DISTRICT); SECTION 2 (PERMITTED USES); CHAPTER 11 (OLD TOWN PRESERVATION DISTRICT); SECTION 3 (DEFINITIONS); SECTION 4 (USES); AND SECTION 9 (APPLICATION AND INTERPRETATION); CHAPTER 13 (OFF STREET PARKING AND LOADING); SECTION 4 (OFF STREET PARKING REGULATIONS); CHAPTER 14 (SIGNS); SECTION 6 (SIGNS NOT REQUIRING PERMIT); SECTION 8 (GENERAL SIGN REGULATIONS); AND SECTION 11 (SIGNS IN BUSINESS DISTRICTS (B-1, B-2, B-3, B-4) AND FOR COMMERCIAL USES IN PLANNED UNIT DEVELOPMENT DISTRICTS OF 250 ACRES OR MORE)); AND CHAPTER 20 (EXTERIOR LIGHTING); SECTION 7 (GENERAL REQUIREMENTS); WITHIN THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS was passed.

A RESOLUTION AUTHORIZING THE EXECUTION OF A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE FEDERAL BUREAU OF INVESTIGATION (FBI) CONCERNING THE BLOOMINGDALE POLICE DEPARTMENT'S PARTICIPATION IN THE CYBER CRIMES TASK FORCE was adopted.

A RESOLUTION AUTHORIZING THE EXECUTION OF AN ILLINOIS DEPARTMENT OF COMMERCE AND ECONOMIC OPPORTUNITY GRANT #12-203625 FOR VILLAGE INFRASTRUCTURE AND DRAINAGE IMPROVEMENTS was adopted.

A RESOLUTION AUTHORIZING THE EXECUTION OF AN ILLINOIS DEPARTMENT OF COMMERCE AND ECONOMIC OPPORTUNITY GRANT #13-203262 FOR VILLAGE INFRASTRUCTURE AND DRAINAGE IMPROVEMENTS was adopted.

WARRANT #2 FOR THE MONTH OF OCTOBER, 2013 in the amount of \$2,158,330.52 was approved as presented.
