A Summary of Recent Actions Taken by the Bloomingdale Village Board of Trustees

**VILLAGE BOARD MEETING
MONDAY – FEBRUARY 24, 2014**

AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 8 (CLASSIFICATION OF LICENSES; FEES), SECTION 10 (NUMBER OF LICENSES), SECTION 16 (HOURS OF OPERATION), AND SECTION 23 (PROHIBITED CONDUCT) TO CREATE A CLASS "V" VIDEO GAMING SUPPLEMENTAL LIQUOR LICENSE FOR CLASS "D" - DINING, CLASS "H" - HOTEL AND CLASS "R" - RESORT LIQUOR LICENSE CLASSIFICATIONS was passed.

AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, BY REPEALING TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 10 (VIDEO GAMING); IN ITS ENTIRETY AND REPLACING IT WITH A NEW CHAPTER 10 WITH THE SAME TITLE was passed.

AN ORDINANCE APPROVING THE OFFICIAL ZONING MAP OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS was passed.

A RESOLUTION AUTHORIZING AND APPROVING THE POLICE TOWING SPECIFICATIONS AND AGREEMENT BETWEEN BLOOMINGDALE RESCUE AND RECOVERY AND THE VILLAGE OF BLOOMINGDALE FOR POLICE TOWING SERVICES was adopted.

A RESOLUTION TO ADOPT MUNICIPAL LEGISLATIVE POSITIONS AND PRIORITIES FOR THE 2014 LEGISLATIVE SESSION was adopted.

WARRANT #2 FOR THE MONTH OF FEBRUARY, 2014 in the amount of \$1,142,107.56 was approved as presented.

ST. AUBIN NURSERY of Kirkland, Illinois was award the bid for the 2014 Spring Tree Planting Program in the amount of \$172,059.

PINE LANDSCAPING, INC. of Carol Stream, Illinois was award a three-year contract for Village-Wide Landscape Maintenance Services at the fixed unit price of \$4,422.22 per month or \$39,800 per fiscal year.

TREES "R" US, INC. of Wauconda, Illinois was award the contract for the FY14 & FY15 Tree Pruning Maintenance Program in the amount of \$32,000 per year.
