**A Summary of Recent Actions Taken by the  
Bloomingdale Village Board of Trustees**

**VILLAGE BOARD MEETING  
MONDAY – MARCH 24, 2014**

**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED; TITLE 4 (BUSINESS AND LICENSE REGULATIONS), CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 8 (CLASSIFICATION OF LICENSES; FEES), AND SECTION 16 (HOURS OF OPERATION) TO CREATE AN ADDITIONAL LICENSE FEE FOR CLASS "D-2" DINING – FULL LIQUOR ESTABLISHMENTS TO EXTEND THEIR CLOSING TIME BY ONE (1) HOUR was passed.**

**A RESOLUTION FOR IMPROVEMENTS BY MUNICIPALITY UNDER THE ILLINOIS HIGHWAY CODE (2014 VILLAGE-WIDE STREET IMPROVEMENT PROGRAM) was adopted.**

**A RESOLUTION AUTHORIZING CESAR'S SPORTS BAR AND GRILL TO EXTEND ITS HOURS OF OPERATION AS A MINOR EXCEPTION TO ORDINANCE NO. 2013-23 (AN ORDINANCE APPROVING SPECIAL USE PERMITS FOR ALCOHOLIC BEVERAGE SERVICE AND LIVE ENTERTAINMENT, AND REPEALING ORDINANCE NO. 92-40 (AN ORDINANCE GRANTING A SPECIAL USE PERMIT FOR OPERATION OF EIGHT (8) ELECTRONIC AND TWO (2) MANUAL GAMES WITHIN AN EXPANDED GAME ROOM ON THE PROPERTY OF ROSATI'S PIZZA, A RESTAURANT SERVING ALCOHOLIC BEVERAGES, LOCATED AT 185 EAST LAKE STREET, BLOOMINGDALE, ILLINOIS WITHIN THE CIRCLE CENTER PLANNED UNIT DEVELOPMENT) IN ITS ENTIRETY WITHOUT REPLACEMENT) was adopted.**

**A RESOLUTION ACCEPTING OWNERSHIP OF BY THE VILLAGE OF BLOOMINGDALE OF CERTAIN WATER SYSTEM IMPROVEMENTS PURSUANT TO A SUCCESSOR DEVELOPER'S AGREEMENT FOR ACCEPTANCE OF THE PUBLIC IMPROVEMENTS AND A BILL OF SALE (MEDINAH ON THE LAKES) was adopted.**

**A TEMPORARY LAND USE PERMIT to allow All Around Amusements to operate a Carnival with set up beginning between May 2<sup>nd</sup> and 5<sup>th</sup>, 2014 and removal completed by May 12, 2014 at the Stratford Crossing Shopping Center was approved.**

**WARRANT #2 FOR THE MONTH OF MARCH, 2014 in the amount of \$1,101,662.90 was approved as presented.**

**CONTRACTS, BIDS, & PURCHASES**

**A LAMP CONCRETE CONTRACTORS, INC.** of Schaumburg, Illinois was awarded the bid for the 2014 Village-Wide Street Improvement Program, including other infrastructure improvements, in the amount of \$1,026,889.40.

**MCALLISTER EQUIPMENT COMPANY** of Villa Park, Illinois was awarded the bid for a Doosan Model G125WCU-3Q-T4i Mobile Generating System in the amount of \$48,765.00.

**MONDI CONSTRUCTION, INC.** of West Chicago, Illinois was awarded the bid for the Lake Street Sidewalk Improvements Program in the amount of \$165,958.50.

**PLANNING, ZONING & ENVIRONMENTAL CONCERNS**

**MR. MARK WARDISIANI, OWNER OF LOT 35, AT 132 CUNNINGHAM DRIVE IN THE WESTLAKE UNIT 6 SUBDIVISION**, presented his proposal to approve a Plat of Consolidation to allow Parcel B to be consolidated with Lot 35. The Board authorized the preparation of documentation to approve said Plat of Consolidation.

**MR. KENNETH L. NYENHUIS ON BEHALF OF SBLV INVESTMENTS, LLC., D/B/A JASPER MEATS** at 220 Madsen Drive, presented his proposal for approval of an amendment to or repeal of Ordinance No. 2008-48, an amendment to Ordinance No. 2007-42, a Plat of Consolidation and a final Site Plan. The Board authorized the preparation of an ordinance and documentation to approve said Plat of Consolidation.

**INDUSTRIAL DEVELOPMENT INTERNATIONAL, INC. ("IDI")** presented their proposal for approval of a Plat of Subdivision of Lot 6 of the Bloomingdale Corporate Center Business Park. The Board authorized the preparation of documentation to approve said Plat of Subdivision.
