**A Summary of Recent Actions Taken by the
Bloomingdale Village Board of Trustees**

**VILLAGE BOARD MEETING
MONDAY – AUGUST 25, 2014**

MAYOR COLADIPIETRO PROCLAIMED THE MONTH OF SEPTEMBER, 2014 AS CHILDHOOD CANCER AWARENESS MONTH in Bloomingdale. The Mayor encouraged residents and businesses to help raise awareness and funds for childhood cancer research by wearing gold throughout the month of September in recognition of those who have waged and continue to wage a battle against cancer especially recognizing the efforts of residents seventeen Janine Delaney, childhood cancer survivor and four-year old, Lorenzo Ravenna, currently battling a rare form of cancer.

MAYOR COLADIPIETRO APPOINTED PATRICK SHANNON to the Plan Commission and Zoning Board of Appeals to fill the unexpired term of Alex Zevan.

AN ORDINANCE AUTHORIZING THE ACQUISITION OF AND APPROVING A COMMERCIAL SALES CONTRACT FOR THE REAL ESTATE COMMONLY REFERRED TO AS 112 – 114 W. LAKE STREET, BLOOMINGDALE, ILLINOIS, 60108 was passed.

AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES) TO INCREASE THE NUMBER OF CLASS "E" LICENSES (ROUND ONE ENTERTAINMENT, INC.) was passed.

WARRANT #2 FOR THE MONTH OF AUGUST, 2014 in the amount of \$1,519,563.42 was approved as presented.

CIS INSURANCE AND ALDEN CHILDREN'S HOME presented their proposal to amend Ordinance No. 2005-33 and approve: (1) a special use allowing a planned development; (2) a Plat of Consolidation; (3) a re-zoning of a parcel from B-2 Community Business District to R-3, Multiple Family Residential District – Special Use - Planned Development; and (4) a final site plan for the property located at 261 – 267 East Lake Street. The Board approved their petition.

THE PUBLIC HEARING ON THE REQUEST BY RONALD AND SHARON KAMMES (Kammes Truck Repair, 501 West Army Trail Road) to approve a second amendment to the Annexation Agreement originally scheduled for August 25, 2014 at 7:00 p.m. was approved to be postponed to September 8, 2014 at 7:00 p.m.
