**A Summary of Recent Actions Taken by the
Bloomingdale Village Board of Trustees**

**VILLAGE BOARD MEETING
MONDAY – JUNE 9, 2014**

AN ORDINANCE APPROVING A FINAL SITE PLAN TO ALLOW EXPANSION, LIGHTING AND LANDSCAPING OF A PARKING LOT FOR SHREE RADHE SHYAM TEMPLE (SHREE RADHE SHYAM TEMPLE, 245 SOUTH BLOOMINGDALE ROAD) was passed.

AN ORDINANCE APPROVING AN AMENDMENT TO ORDINANCE NO. 2008-28 TO ALLOW EXPANSION OF AN EXISTING MASSAGE ESTABLISHMENT FROM 1,350 SQUARE FEET TO 2,455 SQUARE FEET AT THE PROPERTY COMMONLY KNOWN AS STRATFORD CROSSING SHOPPING CENTER (ELEMENTS MASSAGE, 142 SOUTH GARY AVENUE, SUITE 104) was passed.

AN ORDINANCE APPROVING (1) TEXT AMENDMENTS TO TITLE 11, ZONING REGULATIONS, OF THE VILLAGE CODE TO ALLOW RESALE RETAIL USES AS A SPECIAL USE IN THE B-3 GENERAL SERVICES BUSINESS DISTRICT; (2) A SPECIAL USE FOR THE DONATION DROP OFF DRIVE-THROUGH LOCATION; (3) AN AMENDMENT TO ORDINANCE NO. 92-13; (4) EXCEPTIONS FOR OFF STREET PARKING AND (5) A FINAL SITE PLAN (GOODWILL, 420 WEST ARMY TRAIL ROAD) was passed.

THE OLD TOWN PARKING LOT was discussed.

LITTLE CITY FOUNDATION presented their proposal for 1) a Text Amendment to Title 11, Zoning Regulations, of the Village Code ("Code") to add a definition of Group Home to Section 2; (2) a Text Amendment to Section 7 of the Code to add the category of Group Home as a Special Use in Section 7; and (3) approval of a Special Use to allow a Group Home for eight (8) adults and two (2) supervisors at a single family residence in an R-2 Single Family Residential District at 116 Greenway Drive. The Board denied their petition.

WARRANT #1 FOR THE MONTH OF JUNE, 2014 in the amount of \$1,023,654.86 was approved as presented.
