### A Summary of Recent Actions Taken by the Bloomingdale Village Board of Trustees

**VILLAGE BOARD MEETING  
MONDAY – JULY 14, 2014**

**AN ORDINANCE AMENDING ORDINANCE NO. 1971-53 AND APPROVING (1) A SPECIAL USE FOR, AND THE ESTABLISHMENT OF, A PLANNED DEVELOPMENT; (2) EXCEPTIONS TO THE VILLAGE CODE; (3) A PLAT OF CONSOLIDATION; AND (4) A FINAL SITE PLAN TO ALLOW CONSTRUCTION OF A NEW DAY SCHOOL (MARKLUND HOME, INC., 164 SOUTH PRAIRIE AVENUE) was passed.**

**AN ORDINANCE VACATING A PORTION OF PRAIRIE AVENUE RIGHT-OF-WAY WITH TITLE GOING TO MARKLUND CHILDREN'S HOME WITH A RESERVATION OF CERTAIN UTILITY EASEMENTS WITHIN THE VACATED RIGHT-OF-WAY was passed.**

**AN ORDINANCE AUTHORIZING THE SALE OR DISPOSAL OF SURPLUS PROPERTY, (COMPUTER & ELECTRONIC EQUIPMENT, CELL PHONES, POLICE RADIOS, AND MISCELLANEOUS RADIO EQUIPMENT), OWNED BY THE VILLAGE OF BLOOMINGDALE was passed.**

**CORNERSITE DEVELOPMENT, LLC**, presented their proposal for approval of the repeal of Ordinance No. 84-35; a special use to allow a planned development and a drive through service; exceptions to the Village Code; and final site plan for the property located at 430 West Army Trail Road. The Board authorized the preparation of an ordinance.

**STRATFORD SQUARE MALL (STREET MAC, LLC)** request for a Temporary Land Use Permit for a three (3) day Circus with two (2) performances each day by the Kelly Miller Circus to benefit the Bloomingdale-Roselle Rotary Club in the Stratford Square Mall unified shopping center on September 12, 2014 to September 14, 2014 was approved.

**THE TRAFFIC INVESTIGATION OF PRAIRIE AVENUE** (Schick Road South to Dead End) was presented. The Board authorized the preparation of an ordinance to establish a "School Speed Zone" posted at a maximum speed of 20 mph and the necessary actions to post signage and to enforce "No Bus Parking, Standing or Stopping" on Prairie Avenue between Schick Road south to the dead end and a change to the current traffic controls to an all-way stop control at the intersection of Schick Road and Prairie Avenue.

**WARRANT #1 FOR THE MONTH OF JULY, 2014** in the amount of \$1,618,502.91 was approved as presented.

**CONTRACTS, BIDS, & PURCHASES**

**J & M DECORATING, INC.** of Addison, IL was awarded the contract for the FY14 Bloomingdale Golf Club Clubhouse Exterior Painting Project in the amount of \$34,750.00.

**LECHNER & SONS UNIFORM RENTAL** of Mt. Prospect, IL was awarded a multi-year uniform rental contract in the total amount of \$19,050.00 based on their 2012 unit pricing structure for the remainder of FY15, and all of FY16 and FY17.

**RMC IMAGING, INC.** of Rockford, IL was awarded the contract for two (2) ST Imaging ViewScan III digital microfilm/fiche scanners at a total cost of \$14,690.00.

**THE JOINT ORDER CONTRACTING PROCUREMENT METHOD** was approved for the completion the roof replacement of the Bloomingdale Golf Course Clubhouse.

**THE SERVER VIRTUALIZATION AND BACKUP/DISASTER RECOVERY PROJECT** proposals received were rejected.
