**A Summary of Recent Actions Taken by the  
Bloomingdale Village Board of Trustees**

**VILLAGE BOARD MEETING  
MONDAY – OCTOBER 27, 2014**

**AN ORDINANCE AUTHORIZING AND APPROVING THE EXECUTION OF AN ANNEXATION AGREEMENT (SPRINGFIELD PLACE SUBDIVISION-24W411 LAWRENCE AVENUE AND 24W435 LAWRENCE AVENUE) was passed.**

**AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS (24W411 LAWRENCE AVENUE AND 24W435 LAWRENCE AVENUE) was passed.**

**AN ORDINANCE APPROVING A TEXT AMENDMENT TO THE ZONING REGULATIONS TO ESTABLISH AN R2-C SINGLE FAMILY RESIDENTIAL ZONING DISTRICT; A REZONING FROM ER-1 TO R-2C -- SPECIAL USE PLANNED DEVELOPMENT WITH EXCEPTIONS; A FINAL PLAT OF SUBDIVISION; AND A FINAL SITE PLAN UPON ANNEXATION TO ALLOW THE DEVELOPMENT OF 23 SINGLE-FAMILY RESIDENCES (SPRINGFIELD PLACE SUBDIVISION--24W411 AND 24W435 LAWRENCE AVENUE) was passed.**

**AN ORDINANCE APPROVING REPEAL OF ORDINANCE NO. 92-15, A SPECIAL USE FOR DRIVE-THROUGH SERVICE, EXCEPTIONS TO THE VILLAGE CODE, AND A FINAL SITE PLAN (CHICK-FIL-A – 354 WEST ARMY TRAIL ROAD) was passed.**

**AN ORDINANCE AMENDING CHAPTER 1 OF TITLE 2, BOARDS, COMMISSIONS AND COMMITTEES, AND CHAPTERS 5, 8, 9, 10, AND 14 OF TITLE 11, ZONING REGULATIONS, AS AMENDED, REGARDING THE CREATION OF A PLANNING AND ZONING COMMISSION, NON-CONFORMING SIGNS, REAL ESTATE SIGNS, SIGNS IN UNIFIED SHOPPING CENTERS, CHANGES TO APPROVED PLANS, OUTDOOR DINING, AND PROVISIONS FOR FIREARMS PRACTICE FACILITY AS A SPECIAL USE was passed.**

**AN ORDINANCE AUTHORIZING THE DISPOSAL OF SURPLUS PERSONAL PROPERTY OWNED BY THE VILLAGE OF BLOOMINGDALE (OFFICE CHAIRS) was passed.**

**A RESOLUTION APPROVING AN AMENDMENT TO THE INTERGOVERNMENTAL LOCAL AGENCY MASTER AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE AND THE ILLINOIS DEPARTMENT OF TRANSPORTATION DEFINING JURISDICTION AND MAINTENANCE RESPONSIBILITIES AND THE APPORTIONMENT OF MAINTENANCE AND ENERGY COSTS FOR LOCAL BENEFIT TRAFFIC CONTROL DEVICES LOCATED ON STATE HIGHWAYS WITHIN THE VILLAGE OF BLOOMINGDAL was adopted.**
