**A Summary of Recent Actions Taken by the
Bloomingdale Village Board of Trustees**

**VILLAGE BOARD MEETING
MONDAY – DECEMBER 15, 2014**

A PUBLIC HEARING PURSUANT TO THE TRUTH IN TAXATION ACT CONCERNING THE 2014 TAX LEVY OF THE VILLAGE OF BLOOMINGDALE, INCLUDING THE BLOOMINGDALE PUBLIC LIBRARY was held.

AN ORDINANCE LEVYING TAXES FOR CORPORATE PURPOSES OF THE VILLAGE OF BLOOMINGDALE FOR THE CURRENT FISCAL YEAR COMMENCING ON MAY 1, 2014 TO APRIL 30, 2015 was passed.

A RESOLUTION APPROVING A RECIPROCAL AGREEMENT ON EXCHANGE OF INFORMATION BETWEEN THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS AND THE ILLINOIS DEPARTMENT OF REVENUE was adopted.

A RESOLUTION AUTHORIZING AND APPROVING A FINANCIAL REIMBURSEMENT INTERGOVERNMENTAL AGREEMENT BETWEEN BLOOMINGDALE TOWNSHIP AND THE VILLAGE OF BLOOMINGDALE FOR PARATRANSIT SERVICES was adopted.

A RESOLUTION AUTHORIZING AND APPROVING A 1st AMENDMENT TO INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE AND BLOOMINGDALE PARK DISTRICT (OLD TOWN PARK) was adopted.

WARRANT #1 FOR THE MONTH OF DECEMBER, 2014 in the amount of \$3,891,933.38 was approved as presented.

FY 16 PRELIMINARY BUDGET OF GOLF COURSE & 5-YEAR FORECAST was discussed.

HOME RULES SALES TAX FUND ANALYSIS AND LONG-TERM FORECAST was discussed.

GREENBERGFARROW ON BEHALF OF TEXAS ROADHOUSE presented their request for approval of an amendment to Ordinance No. 95-24; a special use permit to allow alcoholic beverage service in conjunction with a restaurant; exceptions to the Village Code and other ordinances for rear yard landscape setback, signage, and building materials; and a final site plan to allow the construction of a Texas Roadhouse Restaurant at 62 Stratford Drive. The Board authorized the preparation of an ordinance.
