**VILLAGE BOARD MEETING  
MONDAY – JANUARY 26, 2015**

**AN ORDINANCE ABATING LEVY OF TAX AUTHORIZED BY ORDINANCE NO. 2007-34 AN ORDINANCE AUTHORIZING THE ISSUANCE OF \$4,900,000 GENERAL OBLIGATION BONDS, SERIES 2007A, OF THE VILLAGE OF BLOOMINGDALE, ILLINOIS was passed.**

**AN ORDINANCE ABATING LEVY OF TAX AUTHORIZED BY ORDINANCE NO. 2007-35 AN ORDINANCE AUTHORIZING THE ISSUANCE OF \$4,800,000 GENERAL OBLIGATION BONDS, SERIES 2007B, OF THE VILLAGE OF BLOOMINGDALE, ILLINOIS was passed.**

**AN ORDINANCE ABATING LEVY OF TAX FOR THE PAYMENT OF BONDS ISSUED TO REFUND THE 2001 BONDS THAT REFUNDED OBLIGATIONS FOR OPEN SPACE PURPOSES AUTHORIZED BY ORDINANCE NO. 2009-34, AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$11,265,000 GENERAL OBLIGATION REFUNDING BONDS, SERIES 2009, OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, AND PROVIDING FOR THE LEVY AND COLLECTION OF A DIRECT ANNUAL TAX SUFFICIENT FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON SAID BONDS was passed.**

**AN ORDINANCE ABATING LEVY OF TAX FOR THE PAYMENT OF BONDS ISSUED TO REFUND THE 2002 BONDS THAT REFUNDED OBLIGATIONS OF THE VILLAGE ISSUED FOR WATER AND SEWER PURPOSES AUTHORIZED BY ORDINANCE NO. 2009-34, AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$11,265,000 GENERAL OBLIGATION REFUNDING BONDS, SERIES 2009, OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, AND PROVIDING FOR THE LEVY AND COLLECTION OF A DIRECT ANNUAL TAX SUFFICIENT FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON SAID BONDS was passed.**

**AN ORDINANCE APPROVING (1) A TEXT AMENDMENT TO ALLOW DRIVE-THROUGH USES IN THE OD-OFFICE DISTRICT; (2) A SPECIAL USE FOR DRIVE THROUGH BANKING; (3) AN AMENDMENT TO ORDINANCE NO. 96-42 AND NO. 2005-40; (4) CERTAIN EXCEPTIONS TO THE VILLAGE CODE; AND (5) A FINAL SITE PLAN (LFAJJ PARTNERS, LLC, 236 WEST LAKE STREET) was passed.**

**AN ORDINANCE APPROVING A PLAT OF SUBDIVISION FOR PROPERTY OWNED BY THE VILLAGE OF BLOOMINGDALE, LOCATED AT 112 WEST LAKE STREET IN THE VILLAGE OF BLOOMINGDALE, ILLINOIS (112 WEST LAKE STREET) was passed.**
