**A Summary of Recent Actions Taken by the

**SPECIAL VILLAGE BOARD MEETING  
MONDAY – APRIL 13, 2015**

**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES); TO DECREASE THE NUMBER OF CLASS "D" LICENSES (LX Inc., d.b.a. LX Pizza–Char Grill) was passed.**

**AN ORDINANCE RESERVING VOLUME CAP IN CONNECTION WITH PRIVATE ACTIVITY BOND ISSUES AND RELATED MATTERS was passed.**

**A RESOLUTION FOR IMPROVEMENT BY MUNICIPALITY UNDER THE ILLINOIS HIGHWAY CODE (SECTION #15-00063-00-RS) was adopted.**

**A RESOLUTION AUTHORIZING THE INDUCEMENT OF A DEVELOPER FOR THE PURPOSE OF THE DEVELOPMENT OF THE PROPERTY COMMONLY REFERRED TO AS 170 E. LAKE STREET, BLOOMINGDALE, ILLINOIS 60108 was adopted.**

**A RESOLUTION AUTHORIZING THE EXECUTION OF A LAW ENFORCEMENT MUTUAL AID AGREEMENT AND THE EXISTENCE AND FORMATION OF THE ILLINOIS LAW ENFORCEMENT ALARM SYSTEM BY INTERGOVERNMENTAL COOPERATION was adopted.**

**A COMMUNITY GARDEN on the Village property located at Springfield Park by the Bloomingdale Park District pursuant to an existing Lease Agreement, Development Ordinance and Intergovernmental Agreement was approved.**

**WARRANT #1 FOR THE MONTH OF APRIL, 2015 in the amount of \$1,095,134.56 was approved.**

**CONTRACTS, BIDS, & PURCHASES**

**MIDLAND MASONRY, INC.** of Villa Park, Illinois was awarded the bid for the Village of Bloomingdale Masonry Sign in the amount of \$47,629.00.

**PRECISION PAVEMENT MARKINGS, INC.**, of Elgin, Illinois was approved as the vendor for the 2015 (FY16) Annual Pavement Marking-Recessed Reflective Pavement Marker Program in the not-to-exceed amount of \$33,335.70.

**SCHROEDER ASPHALT SERVICES** of Huntley, Illinois was awarded the bid for the 2015 Annual Street Improvement Program, the Crossings at Bloomingdale Storm Sewer Improvement and Other Improvements in the amount of \$1,289,666.38.

**TOTAL FACILITY MAINTENANCE, INC.** of Wood Dale, Illinois was awarded the 2015 Three-Year Custodial Services Contract in the amount of \$33,490.00 per term for FY16, FY17 and FY18 for a total contract amount of \$100,470.00.
