### A Summary of Recent Actions Taken by the Bloomingdale Village Board of Trustees

**VILLAGE BOARD MEETING  
MONDAY – NOVEMBER 28, 2016**

**MAYOR COLADIPIETRO APPOINTED EDWARD LEVATO, JR.** to the Police Pension Board for a term to expire on May 1, 2017.

**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES) TO DECREASE THE NUMBER OF CLASS "D-1" LIQUOR LICENSES, SMASHBURGER ACQUISITION – CHICAGO LLC (D/B/A SMASHBURGER)** was passed.

**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES) TO INCREASE THE NUMBER OF CLASS "GR" GROCERY/RETAILER, LIQUOR LICENSES, ROUNDY'S ILLINOIS, LLC (D/B/A MARIANO'S #8540)** was passed.

**AN ORDINANCE AUTHORIZING THE SALE OR DISPOSAL OF SURPLUS PERSONAL PROPERTY OWNED BY THE VILLAGE OF BLOOMINGDALE (COMPUTER AND ELECTRONIC EQUIPMENT)** was passed.

**DRH CAMBRIDGE, INC. ARBOR POINTE** petition was sent back to the Planning and Zoning Commission for consideration of their revised plans.

**A RESOLUTION TO ALLOW THE VILLAGE OF BLOOMINGDALE TO UNDERTAKE CONSTRUCTION, OPERATION AND MAINTENANCE OF DRIVEWAYS AND STREET RETURNS, WATERMAIN, SANITARY AND STORM SEWERS, STREET LIGHTS, TRAFFIC SIGNALS, SIDEWALKS, AND LANDSCAPING, ETC., ON STATE HIGHWAYS WITHIN THE VILLAGE OF BLOOMINGDALE** was adopted.

**A RESOLUTION ACCEPTING GRANT OF EASEMENT FOR CERTAIN PUBLIC IMPROVEMENTS AT THE BLOOMINGDALE MEMORY CARE FROM THE OWNERS OF CERTAIN PRIVATE PROPERTY LOCATED AT 241 EAST LAKE STREET IN THE VILLAGE OF BLOOMINGDALE, ILLINOIS** was adopted.

**A RESOLUTION ACCEPTING GRANT OF EASEMENTS FOR CERTAIN PUBLIC IMPROVEMENTS IN BCC CORPORATE CENTER FOURTH RESUBDIVISION FROM THE OWNERS OF CERTAIN PRIVATE PROPERTY LOCATED AT 255-270 MADSEN DRIVE IN THE VILLAGE OF BLOOMINGDALE, ILLINOIS** was adopted.

**WARRANT #2 FOR THE MONTH OF NOVEMBER, 2016** in the amount of \$1,110,170.51 was approved as presented.

**THE PAYMENT OF THE INVOICE** from the Village of Addison dated November 15, 2016 for consolidated dispatch services rendered for the period beginning May 1, 2016 through October 31, 2016 in the amount of \$203,846.50 was approved.
