A Summary of Recent Actions Taken by the Bloomingdale Village Board of Trustees

**VILLAGE BOARD MEETING
MONDAY – August 28, 2017**

JUDGE PAUL FULLERTON SWORE IN THE NEWLY APPOINTED BOARD MEMBER: TRUSTEE PATRICK SHANNON. He was appointed by Mayor Coladipietro to fill the unexpired term of Michael Hovde Jr.

MAYOR COLADIPIETRO PROCLAIMED SEPTEMBER 7, 2017 AS “GO ORANGE DAY” in Bloomingdale, in support of National Hunger Awareness Month. The Mayor encouraged Bloomingdale residents and businesses to help raise awareness of hunger in our community by wearing orange on September 7, 2017, and to assist those in need by donating food/supplies (into collection bins located at the partner facilities), and/or volunteering time to Bloomingdale's local food pantries.

MAYOR COLADIPIETRO APPOINTED ANTHONY F. DAMATO to the Planning and Zoning Commission to fill the unexpired term of Patrick Shannon.

A RESOLUTION APPROVING AND AUTHORIZING AN AGREEMENT BY AND BETWEEN THE VILLAGE OF BLOOMINGDALE AND KAY ARGO was adopted.

AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES) TO INCREASE THE NUMBER OF CLASS “C” (CHURCHES, CIVIC GROUPS AND CLUBS) LIQUOR LICENSES, SCOTTISH RITE CATHEDRAL ASSOCIATION OF CHICAGO, 383 EAST LAKE STREET was approved.

CURRIE MOTORS of Frankfurt, IL purchase order in the total amount of \$142,712.00 for the purchase of four Ford Utility (SUV-AWD) Squad cars was approved.

A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF AN INTERGOVERNMENTAL AGREEMENT BY AND BETWEEN THE VILLAGE OF BLOOMINGDALE AND THE COUNTY OF DUPAGE TO PARTICIPATE IN THE DUPAGE JUDICIAL INFORMATION SYSTEM was adopted.

AN ORDINANCE AMENDING TITLE VI CHAPTER 5 OF THE CODE OF ORDINANCES FOR THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS was approved.

A RESOLUTION IN SUPPORT OF THE RENOVATION AND REDEVELOPMENT OF STRATFORD SQUARE MALL BLOOMINGDALE, ILLINOIS 60108 was adopted.
