**VILLAGE BOARD MEETING  
MONDAY – November 27, 2017**

**A RESOLUTION APPROVING A MEMORANDUM OF UNDERSTANDING (REGARDING SICK LEAVE) BETWEEN THE VILLAGE OF BLOOMINGDALE AND THE FRATERNAL ORDER OF POLICE LABOR COUNCIL FOR AND ON BEHALF OF CERTAIN CIVILIAN EMPLOYEES OF THE VILLAGE OF BLOOMINGDALE** was adopted.

**A RESOLUTION APPROVING A MEMORANDUM OF UNDERSTANDING (REGARDING SICK LEAVE) BETWEEN THE VILLAGE OF BLOOMINGDALE AND THE FRATERNAL ORDER OF POLICE LABOR COUNCIL FOR AND ON BEHALF OF FULL-TIME SWORN PEACE OFFICERS BELOW THE RANK OF SERGEANT OF THE VILLAGE OF BLOOMINGDALE** was adopted.

**A RESOLUTION APPROVING A MEMORANDUM OF UNDERSTANDING (REGARDING SUBSTANCE ABUSE TESTING) BETWEEN THE VILLAGE OF BLOOMINGDALE AND THE FRATERNAL ORDER OF POLICE LABOR COUNCIL FOR AND ON BEHALF OF FULL-TIME SWORN PEACE OFFICERS BELOW THE RANK OF SERGEANT OF THE VILLAGE OF BLOOMINGDALE** was adopted.

**AN ORDINANCE AUTHORIZING THE DISPOSAL OF SURPLUS PERSONAL PROPERTY OWNED BY THE VILLAGE OF BLOOMINGDALE (POSTAGE MAILING MACHINE)** was approved.

**A RESOLUTION APPROVING AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGE OF BLOOMINGDALE AND THE COUNTY OF DUPAGE, ILLINOIS FOR THE IMPLEMENTATION OF THE NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PROGRAM IN THE SALT CREEK, EAST BRANCH DUPAGE RIVER AND WEST BRANCH DUPAGE RIVER WATERSHEDS** was adopted.

**OAK BROOK MECHANICAL, INC.** of Elmhurst was awarded a five (5) year contract extension for the current HVAC contract in the total amount of \$324,452.00.

The design build proposal dated September 27, 2017 from **OAK BROOK MECHANICAL SERVICES, INC.**, of Elmhurst in the amount of \$28,274.00 to replace the three (3) RTU units was approved.

**CHICAGOLAND TRENCHLESS REHABILITATION, INC. D/B/A CTR SYSTEMS** of Niles was awarded the contract for the FY18 Television Inspection of Sanitary and Storm Sewers in the amount of \$112,367.30 pursuant to the unit prices contained in their bid proposal dated November 13, 2017.

**A RESOLUTION URGING GOVERNOR RAUNER TO VETO SENATE BILL 1451** was adopted.

**Warrant #2 for the Month of November, 2017** – in the amount of \$1,209,856.92 was approved as presented.

**THE ANNUAL TAX INCREMENT FINANCE (TIF) REPORT** for the Year Ended April 30, 2017 for each of the Village's four (4) TIF Districts was accepted.

**THE FISCAL YEAR ENDING APRIL 30, 2017 COMPREHENSIVE ANNUAL FINANCIAL REPORT** was accepted.
