A Summary of Recent Actions Taken by the Bloomingdale Village Board of Trustees

VILLAGE BOARD MEETING MONDAY – January 8, 2018

GENCO INDUSTRIES, INC. of Crestwood was awarded a contract for the FY18 Sump Pump Replacements at Pump Station #8 Ground Storage Tank including the purchase of a spare sump pump in the total amount of \$39,480.00.

ATLAS COPCO COMPRESSORS LLC of Elk Grove Village was awarded a five (5) year maintenance agreement for three blowers in the total amount of \$127,878.00.

AN ORDINANCE AMENDING THE EMPLOYEE PERSONNEL MANUAL FOR THE VILLAGE OF BLOOMINGDALE, ILLINOIS WITH RESPECT TO ITS POLICY AGAINST DISCRIMINATION AND HARASSMENT, INCLUDING SEXUAL HARASSMENT AND OTHER POLICIES was approved.

IRMA PURCHASE ORDER in the amount of \$327,743.00, representing the Village's calendar year 2018 net contribution, was approved.

AN ORDINANCE ABATING LEVY OF TAX AUTHORIZED BY ORDINANCE NO. 2007-35 AN ORDINANCE AUTHORIZING THE ISSUANCE OF \$4,800,000 GENERAL OBLIGATION BONDS, SERIES 2007B, OF THE VILLAGE OF BLOOMINGDALE, ILLINOIS was approved.

AN ORDINANCE ABATING LEVY OF TAX AUTHORIZED BY ORDINANCE NO. 2015-13 AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$3,420,000 GENERAL OBLIGATION REFUNDING BONDS, SERIES 2015 OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, AND PROVIDING FOR THE LEVY AND COLLECTION OF A DIRECT ANNUAL TAX SUFFICIENT FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON SAID BONDS was approved.

Authorization for the purchase of one Chevy Travers from Biggers Chevy in Elgin in the amount of \$27,129.00 was approved.

Authorization for the purchase of four Ford Utility (SUV-AWD) Interceptors from Currie Motors in the amount of \$113,044.00 was approved.

Warrant #1 for the Month of January, 2018 – in the amount of \$1,709,402.12 was approved as presented.
