A Summary of Recent Actions Taken by the Bloomingdale Village Board of Trustees

REGULAR BOARD MEETING - MONDAY - MARCH 24, 2008

AN ORDINANCE AMENDING CHAPTER 13 AND EXHIBIT A TO THE BLOOMINGDALE COMPREHENSIVE CODE (Paulenzo, Inc.) was approved. Paulenzo Restaurant located at 170 E. Lake Street has closed and no longer requires a liquor license.

AN ORDINANCE AMENDING ARTICLES III, IV, VII, VIII, X-A, XII, XIV AND XVII OF "THE BLOOMINGDALE ZONING ORDINANCE," AS AMENDED, REGARDING CERTAIN DEFINED TERMS, PERMITTED OBSTRUCTIONS AND ENCROACHMENTS, PERMITTED USES IN THE R2-B SINGLE-FAMILY RESIDENCE DISTRICT, PERMITTED AND SPECIAL USES IN THE B-3 GENERAL SERVICE BUSINESS DISTRICT, DEVELOPMENT STANDARDS APPLICABLE TO THE PLANNED UNIT DEVELOPMENT DISTRICT OF 250 ACRES OR MORE, FINES FOR VIOLATION, AUTHORIZED VARIATIONS, SIGNAGE, AND SITE DEVELOPMENT AND PLAN REVIEW was approved.

AN ORDINANCE AMENDING ORDINANCE #90-64 TO ALLOW THE INSTALLATION OF A SIX-PANEL TILE WALL MURAL AND ASSOCIATED LANDSCAPING, TWO ADDITIONAL WALL MOUNTED DIRECTIONAL SIGNS AND THREE ADDITIONAL WALL MOUNTED SHOPPING CENTER DIRECTORY SIGNS (STRATFORD CROSSING SHOPPING CENTER, F/K/A STRATFORD PLAZA SHOPPING CENTER) was approved.

WARRANT #2 FOR THE MONTH OF MARCH, 2008 in the amount of \$904,598.68 was approved as presented.

THE 2008 ZONING MAP dated March 24, 2008 was approved as prepared.

AUTHORIZATION TO REPLACE PERSONNEL IN THE POLICE DEPARTMENT was granted. One Sergeant position vacated by the retirement of Deputy Chief Schrieber and one police officer position was authorized to be filled.

THE VILLAGE HALL AIR INTAKE IMPROVEMENT PROGRAM was discussed.

IN-SITE REAL ESTATE, LLC proposal for approval of their preliminary site plan to permit the demolition of the existing former Tower Records building located at 383 Army Trail Road and replacement with two multi-tenant retail buildings that the Board denied at their previous meeting was discussed. The Board reconsidered the failed motion and referred their revised plans back to the Plan Commission for review and recommendation.
