### **A Summary of Recent Actions Taken by the Bloomington Village Board of Trustees**

#### **REGULAR BOARD MEETING – MONDAY – AUGUST 25, 2008**

**AN ORDINANCE AMENDING CHAPTER 13 AND EXHIBIT A TO THE BLOOMINGDALE COMPREHENSIVE CODE (Marshall Fields Chicago Inc.)** was approved. Macy's no longer requires a liquor license for their store located in Stratford Square.

**AN ORDINANCE AMENDING CHAPTER 13 OF THE BLOOMINGDALE COMPREHENSIVE CODE TO PROVIDE FOR LIQUOR CONTROL (Pashupati LLC – Himalayan Restaurant)** was approved. A liquor license was granted to Pashupati LLC who will be opening their Himalayan Restaurant at 398 W. Army Trail Road.

**AN ORDINANCE GRANTING APPROVAL OF A FINAL PLAN OF PLANNED DEVELOPMENT, FINAL PLAT OF SUBDIVISION AND FINAL SITE PLAN (EDGEWATER TOWNHOMES)** was approved.

**WARRANT #2 FOR THE MONTH OF AUGUST, 2008** in the amount of \$1,037,674.03 was approved as presented.

**RED ROBIN INTERNATIONAL** presented their proposal for the development of a Red Robin Restaurant, to be located at 152 Stratford Square, Suite J, including alterations to the exterior façade of the mall in the vicinity of the restaurant. The Board authorized the preparation of an ordinance.

**CONTRACTS, BIDS, & PURCHASES**

**AFFORDABLE OFFICE INTERIORS** of Carol Stream, IL, was awarded the contract for the purchase of office furniture for the new Office/Laboratory Building at the Water Reclamation Facility in the not-to-exceed amount of \$12,586.48.

**BEHM PAVEMENT MAINTENANCE, INC.** of West Dundee, IL was awarded the contract for crack sealing bituminous pavement based on their unit price (\$0.57) up to the budgeted amount of \$30,000.00.

**CRC CONCRETE RAISING INC.** of Rolling Meadows, IL award the contract for mud-jacking based on their bid unit price of \$45.00 for a total contract cost of \$5,130.00. The Board approved up to \$6,000.00 additional for other areas discovered during construction.

**GOLF CREATIONS** contract cost for the Bloomingdale Indian Lakes Area Open Space Decommissioning Golf Course Features Project in the final total amount of \$193,000.00 was approved.

**KRAMER TREE SPECIALISTS, INC.** of West Chicago, IL costs in regards to the tornado storm damage in the amount of \$12,282.00 were ratified and approved for payment.
