### **A Summary of Recent Actions Taken by the Bloomingtondale Village Board of Trustees**

#### **REGULAR BOARD MEETING – MONDAY – JANUARY 8, 2007**

**AN ORDINANCE ABATING LEVY OF TAX AUTHORIZED BY ORDINANCE 2001-28, AN ORDINANCE PROVIDING FOR THE ISSUE OF \$18,270,000 GENERAL OBLIGATION REFUNDING BONDS, SERIES 2001**, OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, AND FOR THE LEVY AND COLLECTION OF A DIRECT ANNUAL TAX SUFFICIENT TO PAY THE PRINCIPLE AND INTEREST ON SAID BONDS was passed.

**AN ORDINANCE ABATING LEVY OF TAX AUTHORIZED BY ORDINANCE 2002-03, AN ORDINANCE PROVIDING FOR THE ISSUE OF \$8,210,000 GENERAL OBLIGATION REFUNDING BONDS, SERIES 2002**, OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, AND FOR THE LEVY AND COLLECTION OF A DIRECT ANNUAL TAX SUFFICIENT TO PAY THE PRINCIPLE AND INTEREST ON SAID BONDS was approved. With the passage of the above two ordinances, the property tax savings to a Bloomingtondale property owner having a home assessed value of \$104,483 and a market value of \$313,450 is estimated to be \$217.78.

**AN ORDINANCE APPROVING AND AUTHORIZING THE EXECUTION OF AN ANNEXATION AGREEMENT (TASSOS SPYRATOS, 24W507 LAKE STREET)** was approved.

**AN ORDINANCE ESTABLISHING HIRING STANDARDS FOR PART-TIME POLICE OFFICERS IN THE POLICE DEPARTMENT FOR THE VILLAGE OF BLOOMINGDALE** was approved.

**A RESOLUTION AUTHORIZING A LOAN FROM THE WATER POLLUTION CONTROL REVOLVING LOAN FUND FOR SEWAGE SYSTEM IMPROVEMENTS** was adopted.

**THE FINANCIAL STATEMENTS, THAT REPRESENT THE FINAL ACCOUNTING OF THE ACTIVITIES OF THE 2006 SEPTEMBERFEST EVENT**, were accepted as presented.

**CONTRACTS, BIDS, & PURCHASES**

**TESTING SERVICES CORPORATION** of Carol Stream, IL was awarded the contract for complete subsurface soil sampling and analysis at various locations at a not-to-exceed cost of \$8,600.00.

**VISU SEWER** of Bridgeview, IL was awarded the contract for the annual sewer televising program contract based on their lowest responsible bid in the amount not-to-exceed \$76,000.00, the budgeted amount.

**WOLF & COMPANY, LLP** agreement for audit services for the fiscal year ending April 30, 2007 for a total, not-to-exceed, fee of \$30,800.00 was approved.

**FINANCE, PERSONNEL & ADMINISTRATION**

**THE FISCAL YEAR 2006 ANNUAL TAX INCREMENT FINANCE REPORTS** were accepted as presented.

**WARRANT #1 FOR THE MONTH OF JANUARY, 2007** in the amount of \$1,408,576.74 was approved as presented.

**PLANNING, ZONING & ENVIRONMENTAL CONCERNS**

**ALDEN REALTY SERVICES INC.** request for an extension of time for building permits for Alden Gardens, 22W378 Army Trail Road, until June 1, 2008 was granted. An ordinance granting the extension will be prepared.

**THE PLAT OF SUBDIVISION FOR OLDE TOWNE SHOPPES** at 108 East Lake Street was approved.

**TOLL BROTHERS**, on behalf of Bloomingdale Walk Condominiums, presented their request for an amendment to Ordinance Nos. 2006-05 and 2005-06 to allow for modifications to the residential condominium development to be constructed on Parcel B. The Board authorized the preparation of an ordinance to allow for 90 units.

**POLICE & COMMUNITY RELATIONS**

**THE FULL-TIME COMMUNITY SERVICE OFFICER** replacement position was approved. Community Service Officer James Mandock is retiring effective January 21, 2007.
