A Summary of Recent Actions Taken by the Bloomingtondale Village Board of Trustees

REGULAR BOARD MEETING – MONDAY – JULY 9, 2007

AN ORDINANCE MAKING APPROPRIATIONS FOR CORPORATE PURPOSES FOR THE FISCAL YEAR MAY 1, 2007 TO APRIL 30, 2008 was approved.

AN ORDINANCE AMENDING ARTICLE XVII OF “THE BLOOMINGDALE ZONING ORDINANCE,” AS AMENDED, TO MAKE THE REQUIREMENTS FOR SITE DEVELOPMENT AND PLAN REVIEW APPLICABLE TO NEW BUILDINGS AND BUILDING ADDITIONS IN THE SINGLE-FAMILY RESIDENCE DISTRICTS was approved.

A RESOLUTION OF OFFICIAL INTENT (Indian Lakes Resort) was adopted.

THE FIVE-YEAR PLANS FOR THE GOLF COURSE AND WATER AND SEWER FUNDS were accepted.

WARRANT #1 FOR THE MONTH OF JULY, 2007 in the amount of \$1,071,366.72 was approved as presented.

THE TEMPORARY LAND USE PERMIT FOR THE STRATFORD MALL PARKING LOT for USA Tent Sales was denied.

APPROVAL TO CREATE, RECRUIT, AND FILL UTILITIES DIVISION WRF WASTEWATER OPERATOR I POSITION FOR THE UTILITIES DIVISION WATER RECLAMATION FACILITY was granted.

CHANGE ORDERS

OLD SCHOOL REHABILITATION PROJECT, Change Order 6 (M.I.C. Inc.) in the total additional amount of \$2,847.00 was ratified. Change Order 1 (Belmont State Corporation) in the total additional amount of \$2,247.75 was ratified. The total change order amounts are \$4,094.75.

CONTRACTS, BIDS, & PURCHASES

RACK'M UP DISTRIBUTORS, INC. of McHenry, IL was awarded the contract for the replacement truck lift on the basis of their lowest and best bid of \$12,245.00.

RAY'S PLUMBING AND SEWER SERVICES, INC. was awarded the contract for the 2007 Local Drainage Program on the basis of their lowest and best bid of \$74,086.10.

UNDERGROUND PIPE AND VALVE of Plainfield, IL was awarded the contract for the repair clamps/saddles/copper in the amount not-to-exceed \$10,330.50.
