Entry Level Police Officer Testing: Application process; Orientation and Written Test is completed. There were 38 Candidates eligible to attend the Physical Agility Test on Saturday, June 12<sup>th</sup>. There were 4 No Shows and three candidates failed (2 Sit-Ups and 1 Bench Press). Thirty-One Candidates will move onto the Background Phase of the Testing Process.
