PROPERTY TAXES ASSESSED IN 1987 PAID IN 1988

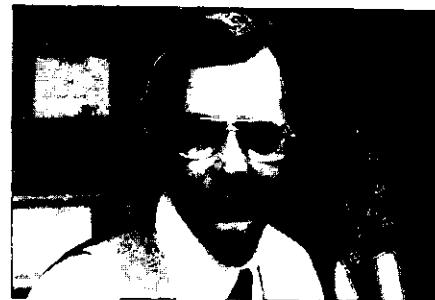
The property tax bill that you received this year was the result of taxes levied in 1987. The Village's tax rate decreased slightly to a rate of .4347 from .4998. The decrease reduced your tax bill approximately \$20.00. The Village Board and myself had previously approved a program wherein a portion of the Corporate tax is collected and set aside to fund the capital portion of Lake Michigan water. The Library levied at a rate of .2761 which was slightly lower than last year.

The Village Board has abated taxes since 1979. Since that time, over 4-million dollars of taxes have been abated:

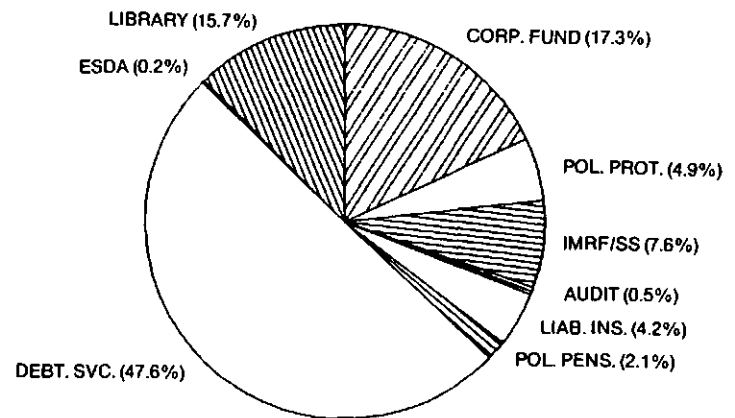

The tax rate of .4347 for the Village portion is one of the lowest Municipal tax rates in DuPage County. It comprises only 5.4% of your total property tax bill. The pie chart below entitled "Typical Residential Tax Bill" exhibits the breakdown of property taxes.

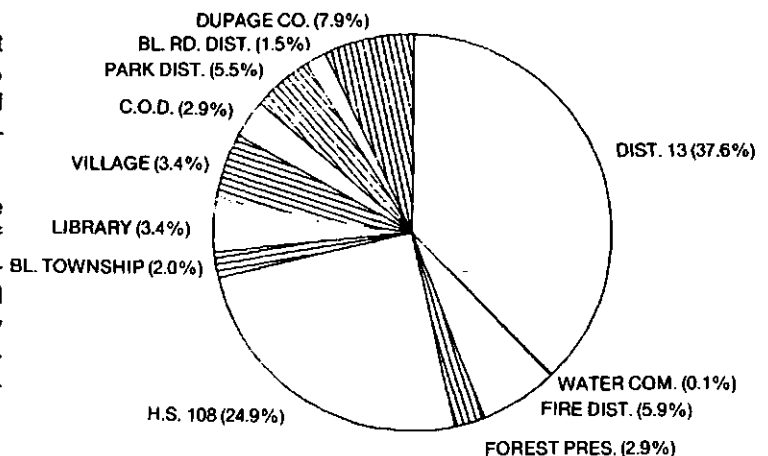
The pie chart entitled "Village Levy" details the percentage breakdown of the portion of your tax bill entitled "Village of Bloomingdale". As you can observe from the chart, approximately one-half of the property taxes levied are used to fund major projects and improvements in the Village as shown by 47.5% allocated to the Debt Service Fund. The General Corporate Fund is responsible for 17.3% of the levy and the Library Funds at 15.7%.

COMMISSION CHANGES

A number of recent appointments and re-appointments have been made to the Village's commissions over the last few months. Patrick DeMoon was re-appointed to the Board of Fire and Police Commissioners and serves as chairman of that board. Robert Denney was re-appointed to the Police Pension Board.

Since last April, the Plan Commission has seen four new members take seats to fill vacancies occurring during the year. Edward Page took his seat as of April 25; Richard Berg and Patrick Kelly were appointed May 9; Frank Korycanek became a member on June 27. Members of the Plan Commission also sit on the Zoning Board of Appeals.

Edward J. Chlipala and Adeline Conti were appointed to the Emergency Services Disaster Agency June 24. Srinath Nandyal was appointed to the Old Town Commission on September 12.

In April of this year the Public Relations Committee was delighted to have Dawn Nemec join as an official member. Dawn had been writing for the Almanac for a number of issues and was sworn in on April 11. She actually is returning to the Almanac staff as she was a feature writer some years back. We are very glad to have her working with us.

SMOKE DETECTORS

A new State law which became effective July 1, 1988 requires every residence to have an approved smoke detector in operating condition within 15 feet of every room used for sleeping purposes.

A smoke detector is also required on every story of the home, including basements. In existing homes, the smoke detectors may be either battery powered or wired into the home's electrical system. In new homes or those being substantially remodeled, the law requires that the smoke detectors be permanently wired into the homes electrical system, and that if more than one detector is required it must be wired so that when one detector is activated, all the detectors will be activated.

1988 TREE PLANTING PROGRAM

The Village Board has again allocated funds for this very successful program which was started in 1982. The program provides trees, including planting, at a 50/50 cost sharing with the Village. The trees will be planted early next Spring and are available for parkways and front yards.

The following are the guidelines of the program:

1. Since the budget is limited, the program will be on a first come, first served basis. Requests should be submitted by December 20, 1988. No money is needed at this time. Bills will be sent in early 1989.
2. Trees will be 2 1/2" caliper, unless stated otherwise.
3. The Village reserves the right to disapprove requests based on conflicts, safety, or proper spacing.
4. Each parcel will be limited to two (2) trees. Corner lots will be allowed four (4) trees.
5. Participants will be given the opportunity to mark the location of the planting desired, but the Village retains the right to change, if necessary.
6. We anticipate the cost of the trees to be between \$200 and \$300 each, with the Village paying half of the amount.
7. Trees will be guaranteed for one year. Participants are responsible for all watering which will be described in instructions furnished by the Village.

FALL HYDRANT FLUSHING VILLAGE OF BLOMINGDALE

It's that time of year again. Starting Tuesday, October 25th through November 17th, the Water Division will be flushing hydrants throughout the Village. The flushing will occur between the hours of 8:00 P.M. and 12:00 midnight. Please **DO NOT WASH LAUNDRY** during the flushing hours, as rust staining of the clothing may result. Residents with water softners are encouraged to check the cycle time of their softners so that the unit does not regenerate during this period.

One question that is always asked is — "Why does the Village flush hydrants?" Hydrant flushing is routine maintenance for a water system. It accomplishes the following:

1. Improves water quality: Flushing removes minerals such as iron and magnesium that have collected in the water mains.
2. Improves water flow: By removing these minerals, the inside diameter of a water main is increased and therefore, allows a better flow of water.
3. Hydrant maintenance: A fire hydrant is a mechanical device. Operation of a hydrant lubricates internal mechanisms and gaskets.
4. Hydrant inspection: Any deficiencies are noted and repaired as necessary to insure that each hydrant will perform when needed for an emergency.

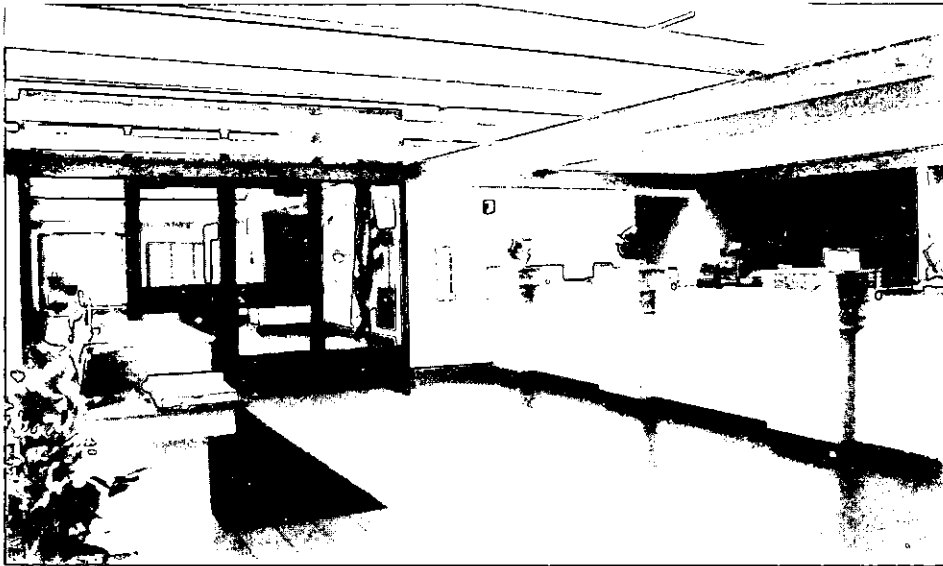

LAKE PARK NHS BENEFITS TOWNSHIP

The Bloomingdale Township Committee on Youth recently received a \$500 donation from the Lake Park High School National Honor Society. Members of the society are selected on the basis of excellence in scholarship, leadership, character and service by the high school faculty.

The group primarily functions as a service organization. This year the members wanted to help troubled teenagers. They voted to donate funds, which had been raised, to a charitable organization involved in suicide prevention. The Bloomingdale Township Committee on Youth was chosen for its efforts in helping young people confront suicidal issues through its family counseling program.

The problem of suicide among young people is of paramount concern to the committee on youth, says director Kathy Thayer. We are finding it to be a growing trend, rather than an isolated problem.

NEW READING CURRICULUM GREETSS DISTRICT 13 CHILDREN

After two years of study and preparation by the district reading committee, a new reading curriculum is being introduced into the classrooms of Bloomington this fall.

The reading philosophy of the district includes "...the ultimate goal of a comprehensive reading program is to foster life long interest and ability in reading". With this in mind the committee last spring choose the Impressions reading series by Holt Publishers for grades kindergarten to second and the Scott Foresman Reading series for grades three to six.

A child's development as a reader is grounded in oral primacy. That is, oral language development is a necessary base upon which all other reading and language skills are developed. Research has indicated that one of the most effective ways in which to promote oral primacy is to immerse the child in early exposure to quality literature and to help each child respond to that literature in a variety of ways. The Impression series provides 100% quality literature and will be used to increase a child's oral primacy and interaction with language in listening, speaking, writing, and reading, sometimes referred to as a whole language reading approach.

A second way in which children grow in language is by learning that language is communication. Students who write regularly as part of the comprehensive

reading program learn that they, as well as the author, have ideas to communicate. Early encouragement of written communication is crucial to a child's development as a reader. Impressions provides students with the opportunity to write and to use quality literature as their model for writing. At grades K-2 Impressions will be used as the major element of the instructional program towards this purpose.

In addition the Impressions program features high quality, patterned literature; themed units; pre, during, and post reading activities, and phonics.

The Scott Foresman reading series was selected for use in grades 3-6 for similarly sound reasons. The presentation of lessons in the Scott match the reading philosophy which states, "Reading comprehension involves a merger between the reader, the text, and the context... To get meaning from a given text, readers must use different skills and strategies." These strategies include analyzing the reading task; activating a reader's prior knowledge; establishing a purpose for reading; planning and implementing appropriate strategies while reading; monitoring understanding while reading; and reflecting upon the reading task upon completion of reading.

Other qualities which impressed the reading committee included quality, classic children's literature included in the basal; preteaching skills which the child needs for understanding of the story is a key element in this series; themed units of instruction allows children to develop conceptual thought about their reading; word study skills are all accomplished within the themed approach to reading; strategy instruction is an essential part of the program; and there is emphasis on reading context area (expository) text.

During this year the reading committee will evaluate the new reading curriculum. Hopefully parents too, will be involved in discussion with their children regarding their progress in the new reading program.

M.O.M.S

M.O.M.s or Morning Out Mom is a program sponsored by Bloomingdale Church, 260 Glen Ellyn Road. Once a month M.O.M.s features a creative, but simple hands-on craft, a short, informational lecture, and child care. Kid of the Kingdom is a structured class of preschoolers and the well-staffed nursery for babies is called Noah's Ark.

The sessions are held the second Tuesday of the month beginning at 9:30 a.m. The October 11 session will feature Wilton candy-making. November 8 the craft will be a rope door wreath, along with holiday traditions discussion. The December 13 session will feature Christmas times with Naomi Cole and a net Christmas tree craft.

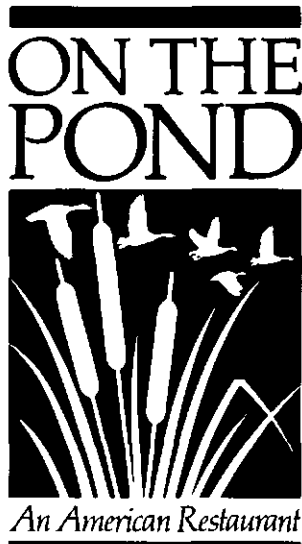

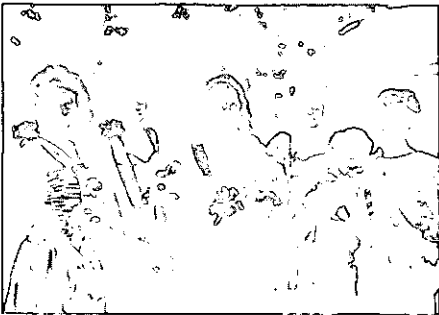


ABOUT TOWN

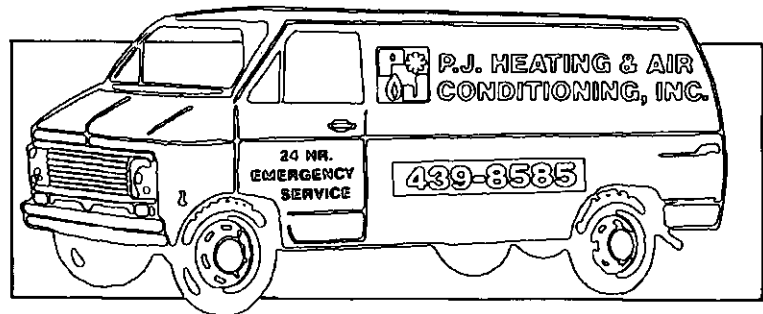

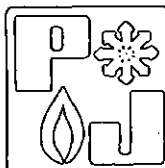

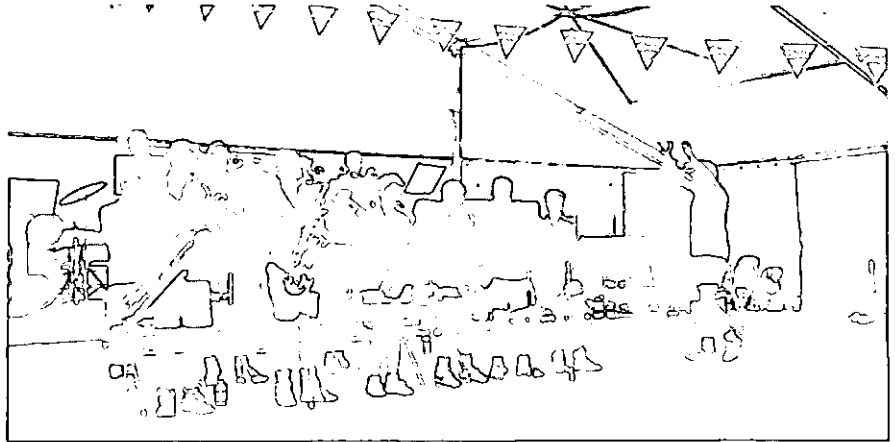

I saw people dancing in back of the tent, I knew we were doing a good job." Congratulations to those most talented young people.

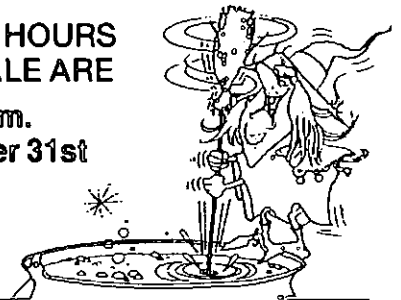

LIBRARY DEPARTMENTS

CIRCULATION DEPARTMENT

In this Issue the library is focusing the spotlight on the Circulation Department. This is that special group of people who are responsible for the checking out and checking in of all the circulating materials in the library. In order for patrons to check out any material, they must have a valid Bloomingdale Public Library borrower's card. By presenting identification showing that they are a resident of the Village of Bloomingdale, a library card is issued and it is valid for three years. The circulation staff knows the Village's boundaries and most of the names of the streets in the Village. Every day new patrons are registered and the information is entered into the computer, which enables the patrons to check out materials from all the libraries in the DuPage Library System.

In addition to these duties, the circulation staff keeps track of overdue material, items placed on reserve, audio/visual rental, inter-library loans, and the shelving of the collection. Often the staff can be seen doing jobs that are not part of the official job description... finding a lost parent, giving directions to a delivery person, offering a tissue in an emergency or lending a helping hand.

The circulation staff consists of the department supervisor, Sally Mee, four clerks and three pages. Dolores Schram has been with the library for six years. As the senior member of the

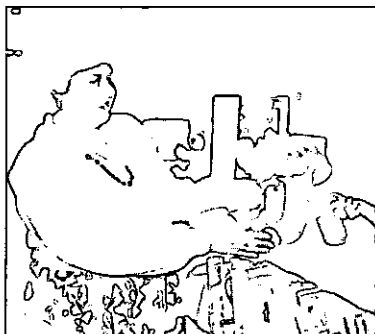

Insured employees then pick and choose health related activities on which to spend their share of the wellness fund. They apply to the Wellness Board for the money to finance all or a portion of their activity.

In order to help employees become more aware of their own health needs, the Wellness Board sponsored a health risk appraisal program last winter. A local hospital administered various tests, pertaining to life style, blood pressure, blood (cholesterol, etc.), body fat, colon and lung cancer, stress, and nutrition. The results of these tests helped employees determine "Where to Start" in their own health program.

Next a health fair was sponsored by the Wellness Board. Representatives from many organizations which deal with health related matters were present to help employees determine if that organization could help them achieve better health habits. Whether the problem was smoking, too much eating, or not enough exercise, each employee had a chance to see what activities were available for them.

Many employees joined health clubs, some received assistance with smoking; and others looked into better diets. Many purchased exercise equipment to use at home.


Additional activities were provided by the Wellness Board. Y-Me, a cancer detection organization, presented a program for all female employees. A number of people took part in a nine week weight control program monitored by a local hospital. (A combined weight loss of over 300 pounds was realized by participants.) Each school in District 13 also has a wellness library which contains exercise tapes and information, as well as books including "Your Good Health", "The California Nutrition Book", "The Pharmacist's Prescription" and "The Complete Book of Health."

District 13 employees are certainly healthier these days because they are doing something about their own good health, instead of just talking about it.



